AN ACT in relation to civic centers.

Be it enacted by the People of the State of Illinois,represented in the General Assembly:

Section 5. The Civic Center Code is amended by changing
Sections 2-125, 2-126, 2-127, 2-128, 25-55, 55-45, 90-35,
105-45, 140-50, 155-55, 170-50, 200-50, 205-75, 215-55,
240-50, and 280-80 as follows:

Sec. 2-125. Contracts; award to other than highest or 9 lowest bidder by vote of 5 Board members. All contracts for 10 the sale of property of the value of more than $\frac{10,000}{2,500}$ 11 12 or for a concession in or lease of property, including air 13 rights, of the Authority for a term of more than one year shall be awarded to the highest responsible bidder, after 14 15 advertising for bids. All construction contracts and contracts for supplies, materials, equipment and services, 16 when the expense thereof will exceed $\frac{10,000}{52,500}$, shall be 17 18 let to the lowest responsible bidder after advertising for 19 bids, excepting (1) when repair parts, accessories, equipment 20 or services are required for equipment or services previously furnished or contracted for; (2) when the nature of the 21 22 services required is such that competitive bidding is not in the best interest of the public, including, without limiting 23 the generality of the foregoing, 24 the services of accountants, architects, attorneys, engineers, physicians, 25 26 superintendents of construction, and others possessing a high 27 degree of skill; and (3) when services such as water, light, heat, power, telephone or telegraph are required. 28

All contracts involving less than \$10,000 \$2,500 shall be let by competitive bidding to the lowest responsible bidder whenever possible, and in any event in a manner calculated to

ensure the best interests of the public. Competitive bidding
 is not required for the lease of real estate or buildings
 owned or controlled by the Authority. The Board is empowered
 to offer such leases upon such terms as it deems advisable.

In determining the responsibility of any bidder, the 5 б Board may take into account the past record of dealings with 7 the bidder, the bidder's experience, adequacy of equipment, 8 and ability to complete performance within the time set, and other factors besides financial responsibility, but in no 9 case shall any such contracts be awarded to any other than 10 11 the highest bidder (in case of sale, concession or lease) or 12 the lowest bidder (in case of purchase or expenditure) unless 13 authorized or approved by a vote of at least 5 members of the Board, and unless such action is accompanied by a statement 14 15 in writing setting forth the reasons for not awarding the 16 contract to the highest or lowest bidder, as the case may be, which statement shall be kept on file in the principal office 17 of the Authority and open to public inspection. 18

Members of the Board, officers and employees of the Authority, and their relatives within the fourth degree of consanguinity by the terms of the civil law are forbidden to be interested directly or indirectly in any contract for construction or maintenance work or for the delivery of materials, supplies or equipment.

The Board shall have the right to reject all bids and to readvertise for bids. If after any such advertisement no responsible and satisfactory bid, within the terms of the advertisement, shall be received, the Board may award such contract without competitive bidding, provided that it shall not be less advantageous to the Authority than any valid bid received pursuant to advertisement.

The Board shall adopt rules and regulations to carry into effect the provisions of this Section.

All contracts for 3 4 the sale of property of the value of more than $\frac{10,000}{2,500}$ or for a concession in or lease of property including air 5 rights, of the Authority for a term of more than one year 6 7 shall be awarded to the highest responsible bidder, after 8 advertising for bids. All construction contracts and contracts for supplies, materials, equipment and services, 9 when the expense thereof will exceed $\frac{10,000}{2,500}$, shall be 10 11 let to the lowest responsible bidder, after advertising for 12 bids, excepting (1) when repair parts, accessories, equipment or services are required for equipment or services previously 13 furnished or contracted for; (2) when the nature of the 14 services required is such that competitive bidding is not 15 in 16 the best interest of the public, including, without limiting the generality of the foregoing, the services of accountants, 17 architects, attorneys, engineers, physicians, superintendents 18 19 of construction, and others possessing a high degree of 20 skill; and (3) when services such as water, light, heat, 21 power, telephone or telegraph are required.

15 The Board shall have the right to reject all bids and to 16 readvertise for bids. If after any such advertisement no 17 responsible and satisfactory bid, within the terms of the 18 advertisement, shall be received, the Board may award such 19 contract, without competitive bidding, provided that it shall 20 not be less advantageous to the Authority than any valid bid 21 received pursuant to advertisement.

All contracts for sale of 27 property of the value of more than $\frac{10,000}{2500}$, or for 28 a 29 concession in or lease of property, including air rights, of the Authority for a term of more than one year, shall be 30 awarded to the highest responsible bidder, after advertising 31 for bids. All construction contracts and contracts for 32 33 supplies, materials, equipment and services, when the expense

1 thereof will exceed $\frac{10,000}{92500}$, shall be let to the lowest 2 responsible bidder, after advertising for bids, except: (1) when repair parts, accessories, equipment or services are 3 4 required for equipment or services previously furnished or contracted for; (2) when the nature of the services required 5 is such that competitive bidding is not in the best interest 6 7 of the public, including, without limiting the generality of 8 the foregoing, the services of accountants, architects, 9 engineers, physicians, superintendents attorneys, of construction, and others possessing a high degree of skill; 10 11 and (3) when services such as water, light, heat, power, 12 telephone or telegraph are required.

All contracts involving less than <u>\$10,000</u> \$2500 shall be let by competitive bidding to the lowest responsible bidder whenever possible, and in any event in a manner calculated to ensure the best interests of the public.

A11 construction contracts and contracts for supplies, materials, 21 22 equipment and services, when the expense thereof will exceed $\frac{10,000}{10,000}$ \$2,500, shall be let to the lowest responsible 23 24 bidder, after advertising for bids, excepting (1) when repair parts, accessories, equipment or services are required for 25 equipment or services previously furnished or contracted for; 26 (2) when the nature of the services required is such that 27 competitive bidding is not in the best interest of the 28 29 public, including, without limiting the generality of the 30 foregoing, the services of accountants, architects, 31 engineers, physicians, superintendents attorneys, of construction, and others possessing a high degree of skill; 32 33 and (3) when services such as water, light, heat, power,

If any collusion occurs among 3 4 bidders or prospective bidders in restraint of freedom of competition, by agreement to bid a fixed amount or to refrain 5 from bidding or otherwise, the bids of such bidders shall be 6 7 Each bidder shall accompany his bid with a sworn void. statement that he has not been a party to any such agreement. 8 9 Members of the Board, officers and employees of the Authority, and their relatives within the fourth degree of 10 11 consanguinity by the terms of the civil law, are forbidden to

12 be interested directly or indirectly in any contract for 13 construction of maintenance work or for the delivery of 14 materials, supplies or equipment.

15 The Board shall have the right to reject all bids and to 16 readvertise for bids. If after any such advertisement no 17 responsible and satisfactory bid, within the terms of the 18 advertisement, shall be received, the Board may award such 19 contract, without competitive bidding, provided that it shall 20 not be less advantageous to the Authority than any valid bid 21 received pursuant to advertisement.

The Board shall adopt rules and regulations to carry into effect the provisions of this Section.
