4	"Section 5. The Illinois Municipal Code is amended by
5	changing Sections 11-74.4-3 and 11-74.4-7 as follows:
6	(65 ILCS 5/11-74.4-3) (from Ch. 24, par. 11-74.4-3)
7	Sec. 11-74.4-3. Definitions. The following terms, wherever
8	used or referred to in this Division 74.4 shall have the
9	following respective meanings, unless in any case a different
10	meaning clearly appears from the context.
11	(a) For any redevelopment project area that has been
12	designated pursuant to this Section by an ordinance adopted
13	prior to November 1, 1999 (the effective date of Public Act
14	91-478), "blighted area" shall have the meaning set forth in
15	this Section prior to that date.
16	On and after November 1, 1999, "blighted area" means any
17	improved or vacant area within the boundaries of a
18	redevelopment project area located within the territorial
19	limits of the municipality where:
20	(1) If improved, industrial, commercial, and
21	residential buildings or improvements are detrimental to
22	the public safety, health, or welfare because of a
23	combination of 5 or more of the following factors, each of
24	which is (i) present, with that presence documented, to a

1 meaningful extent so that a municipality may reasonably 2 find that the factor is clearly present within the intent 3 of the Act and (ii) reasonably distributed throughout the 4 improved part of the redevelopment project area:

5 (A) Dilapidation. An advanced state of disrepair 6 or neglect of necessary repairs to the primary 7 structural components of buildings or improvements in 8 such a combination that a documented building 9 condition analysis determines that major repair is 10 required or the defects are so serious and so extensive 11 that the buildings must be removed.

(B) Obsolescence. The condition or process of
falling into disuse. Structures have become ill-suited
for the original use.

15 (C) Deterioration. With respect to buildings, defects including, but not limited to, major defects in 16 the secondary building components such as doors, 17 18 windows, porches, gutters and downspouts, and fascia. 19 With respect to surface improvements, that the 20 condition of roadways, alleys, curbs, gutters, 21 sidewalks, off-street parking, and surface storage 22 areas evidence deterioration, including, but not limited to, surface cracking, crumbling, potholes, 23 24 depressions, loose paving material, and weeds 25 protruding through paved surfaces.

26 (D) Presence of structures below minimum code 27 standards. All structures that do not meet the 28 standards of zoning, subdivision, building, fire, and 29 other governmental codes applicable to property, but 30 not including housing and property maintenance codes.

31 (E) Illegal use of individual structures. The use
32 of structures in violation of applicable federal,
33 State, or local laws, exclusive of those applicable to
34 the presence of structures below minimum code

standards.

(F) Excessive vacancies. The presence of buildings that are unoccupied or under-utilized and that represent an adverse influence on the area because of the frequency, extent, or duration of the vacancies.

(G) Lack of ventilation, light, or sanitary 6 7 facilities. The absence of adequate ventilation for 8 light or air circulation in spaces or rooms without windows, or that require the removal of dust, odor, 9 gas, smoke, or other noxious airborne materials. 10 Inadequate natural light and ventilation means the 11 absence of skylights or windows for interior spaces or 12 13 rooms and improper window sizes and amounts by room area to window area ratios. Inadequate sanitary 14 15 facilities refers to the absence or inadequacy of garbage storage and enclosure, bathroom facilities, 16 hot water and kitchens, and structural inadequacies 17 18 preventing ingress and egress to and from all rooms and units within a building. 19

20 (H) Inadequate utilities. Underground and overhead utilities such as storm sewers and storm drainage, 21 22 sanitary sewers, water lines, and gas, telephone, and electrical services that are shown to be inadequate. 23 24 Inadequate utilities are those that are: (i) of 25 insufficient capacity to serve the uses in the 26 redevelopment project area, (ii) deteriorated, 27 antiquated, obsolete, or in disrepair, or (iii) lacking within the redevelopment project area. 28

29 (I) Excessive land coverage and overcrowding of 30 structures and community facilities. The over-intensive use of property and the crowding of 31 buildings and accessory facilities onto a site. 32 33 Examples of problem conditions warranting the designation of an area as one exhibiting excessive land 34

coverage are: (i) the presence of buildings either 1 2 improperly situated on parcels or located on parcels of inadequate size and shape in relation to present-day 3 4 standards of development for health and safety and (ii) 5 the presence of multiple buildings on a single parcel. For there to be a finding of excessive land coverage, 6 7 these parcels must exhibit one or more of the following 8 conditions: insufficient provision for light and air within or around buildings, increased threat of spread 9 of fire due to the close proximity of buildings, lack 10 of adequate or proper access to a public right-of-way, 11 lack of reasonably required off-street parking, or 12 13 inadequate provision for loading and service.

(J) Deleterious land use or layout. The existence
of incompatible land-use relationships, buildings
occupied by inappropriate mixed-uses, or uses
considered to be noxious, offensive, or unsuitable for
the surrounding area.

19 (K) Environmental clean-up. The proposed 20 redevelopment project area has incurred Illinois 21 Environmental Protection Agency or United States Environmental Protection Agency remediation costs for, 22 or a study conducted by an independent consultant 23 24 recognized as having expertise in environmental 25 remediation has determined a need for, the clean-up of hazardous waste, hazardous substances, or underground 26 27 storage tanks required by State or federal law, 28 provided that the remediation costs constitute a 29 material impediment the development to or 30 redevelopment of the redevelopment project area.

31 (L) Lack of community planning. The proposed
32 redevelopment project area was developed prior to or
33 without the benefit or guidance of a community plan.
34 This means that the development occurred prior to the

adoption by the municipality of a comprehensive or 1 2 other community plan or that the plan was not followed at the time of the area's development. This factor must 3 4 be documented by evidence of adverse or incompatible 5 land-use relationships, inadequate street layout, improper subdivision, parcels of inadequate shape and 6 7 size to meet contemporary development standards, or other evidence demonstrating an absence of effective 8 community planning. 9

(M) The total equalized assessed value of the 10 proposed redevelopment project area has declined for 3 11 of the last 5 calendar years prior to the year in which 12 13 the redevelopment project area is designated or is increasing at an annual rate that is less than the 14 15 balance of the municipality for 3 of the last 5 calendar years for which information is available or is 16 increasing at an annual rate that is less than the 17 18 Consumer Price Index for All Urban Consumers published 19 by the United States Department of Labor or successor 20 agency for 3 of the last 5 calendar years prior to the 21 year in which the redevelopment project area is 22 designated.

(2) If vacant, the sound growth of the redevelopment 23 24 project area is impaired by a combination of 2 or more of 25 the following factors, each of which is (i) present, with 26 that presence documented, to a meaningful extent so that a 27 municipality may reasonably find that the factor is clearly present within the intent of the Act and (ii) reasonably 28 29 distributed throughout the vacant part of the 30 redevelopment project area to which it pertains:

31 (A) Obsolete platting of vacant land that results
32 in parcels of limited or narrow size or configurations
33 of parcels of irregular size or shape that would be
34 difficult to develop on a planned basis and in a manner

with contemporary 1 compatible standards and requirements, or platting that failed to create 2 rights-of-ways for streets or alleys or that created 3 4 inadequate right-of-way widths for streets, alleys, or other public rights-of-way or that omitted easements 5 for public utilities. 6

7 (B) Diversity of ownership of parcels of vacant
8 land sufficient in number to retard or impede the
9 ability to assemble the land for development.

10 (C) Tax and special assessment delinquencies exist 11 or the property has been the subject of tax sales under 12 the Property Tax Code within the last 5 years.

(D) Deterioration of structures or site
improvements in neighboring areas adjacent to the
vacant land.

(E) The area has incurred Illinois Environmental 16 Protection Agency or United States Environmental 17 18 Protection Agency remediation costs for, or a study 19 conducted by an independent consultant recognized as 20 having expertise in environmental remediation has 21 determined a need for, the clean-up of hazardous waste, 22 hazardous substances, or underground storage tanks 23 required by State or federal law, provided that the 24 remediation costs constitute a material impediment to 25 the development or redevelopment of the redevelopment 26 project area.

(F) The total equalized assessed value of the 27 28 proposed redevelopment project area has declined for 3 29 of the last 5 calendar years prior to the year in which 30 the redevelopment project area is designated or is 31 increasing at an annual rate that is less than the 32 balance of the municipality for 3 of the last 5 33 calendar years for which information is available or is increasing at an annual rate that is less than the 34

Consumer Price Index for All Urban Consumers published by the United States Department of Labor or successor agency for 3 of the last 5 calendar years prior to the year in which the redevelopment project area is designated.

(3) If vacant, the sound growth of the redevelopment 6 7 project area is impaired by one of the following factors 8 that (i) is present, with that presence documented, to a 9 meaningful extent so that a municipality may reasonably find that the factor is clearly present within the intent 10 of the Act and (ii) is reasonably distributed throughout 11 the vacant part of the redevelopment project area to which 12 it pertains: 13

(A) The area consists of one or more unused quarries, mines, or strip mine ponds.

(B) The area consists of unused railyards, rail
 tracks, or railroad rights-of-way.

18 (C) The area, prior to its designation, is subject 19 to (i) chronic flooding that adversely impacts on real 20 property in the area as certified by a registered 21 professional engineer or appropriate regulatory agency 22 or (ii) surface water that discharges from all or a part of the area and contributes to flooding within the 23 24 same watershed, but only if the redevelopment project 25 provides for facilities or improvements to contribute 26 to the alleviation of all or part of the flooding.

27 (D) The area consists of an unused or illegal 28 disposal site containing earth, stone, building 29 debris, or similar materials that were removed from 30 construction, demolition, excavation, or dredge sites.

31 (E) Prior to November 1, 1999, the area is not less 32 than 50 nor more than 100 acres and 75% of which is 33 vacant (notwithstanding that the area has been used for 34 commercial agricultural purposes within 5 years prior to the designation of the redevelopment project area), and the area meets at least one of the factors itemized in paragraph (1) of this subsection, the area has been designated as a town or village center by ordinance or comprehensive plan adopted prior to January 1, 1982, and the area has not been developed for that designated purpose.

8 (F) The area qualified as a blighted improved area 9 immediately prior to becoming vacant, unless there has 10 been substantial private investment in the immediately 11 surrounding area.

(b) For any redevelopment project area that has been designated pursuant to this Section by an ordinance adopted prior to November 1, 1999 (the effective date of Public Act 91-478), "conservation area" shall have the meaning set forth in this Section prior to that date.

On and after November 1, 1999, "conservation area" means 17 18 any improved area within the boundaries of a redevelopment 19 project area located within the territorial limits of the 20 municipality in which 50% or more of the structures in the area 21 have an age of 35 years or more. Such an area is not yet a blighted area but because of a combination of 3 or more of the 22 23 following factors is detrimental to the public safety, health, 24 morals or welfare and such an area may become a blighted area:

(1) Dilapidation. An advanced state of disrepair or
neglect of necessary repairs to the primary structural
components of buildings or improvements in such a
combination that a documented building condition analysis
determines that major repair is required or the defects are
so serious and so extensive that the buildings must be
removed.

32 (2) Obsolescence. The condition or process of falling
 33 into disuse. Structures have become ill-suited for the
 34 original use.

(3) Deterioration. With respect to buildings, defects 1 2 including, but not limited to, major defects in the secondary building components such as doors, windows, 3 4 porches, gutters and downspouts, and fascia. With respect 5 to surface improvements, that the condition of roadways, alleys, curbs, gutters, sidewalks, off-street parking, and 6 7 surface storage areas evidence deterioration, including, 8 but not limited to, surface cracking, crumbling, potholes, depressions, loose paving material, and weeds protruding 9 through paved surfaces. 10

(4) Presence of structures below minimum 11 code standards. All structures that do not meet the standards of 12 subdivision, building, 13 zoning, fire, and other governmental codes applicable to property, but not 14 15 including housing and property maintenance codes.

(5) Illegal use of individual structures. The use of
structures in violation of applicable federal, State, or
local laws, exclusive of those applicable to the presence
of structures below minimum code standards.

20 (6) Excessive vacancies. The presence of buildings
21 that are unoccupied or under-utilized and that represent an
22 adverse influence on the area because of the frequency,
23 extent, or duration of the vacancies.

24 (7)Lack of ventilation, light, or sanitary 25 facilities. The absence of adequate ventilation for light 26 or air circulation in spaces or rooms without windows, or 27 that require the removal of dust, odor, gas, smoke, or other noxious airborne materials. Inadequate natural light 28 29 and ventilation means the absence or inadequacy of 30 skylights or windows for interior spaces or rooms and 31 improper window sizes and amounts by room area to window area ratios. Inadequate sanitary facilities refers to the 32 33 absence or inadequacy of garbage storage and enclosure, bathroom facilities, hot water and kitchens, 34 and 1

structural inadequacies preventing ingress and egress to and from all rooms and units within a building.

(8) Inadequate utilities. Underground and overhead 3 4 utilities such as storm sewers and storm drainage, sanitary 5 sewers, water lines, and gas, telephone, and electrical services that are shown to be inadequate. Inadequate 6 utilities are those that are: (i) of insufficient capacity 7 8 to serve the uses in the redevelopment project area, (ii) deteriorated, antiquated, obsolete, or in disrepair, or 9 (iii) lacking within the redevelopment project area. 10

Excessive land coverage and overcrowding 11 (9) of structures and community facilities. The over-intensive 12 use of property and the crowding of buildings and accessory 13 facilities onto a site. Examples of problem conditions 14 15 warranting the designation of an area as one exhibiting excessive land coverage are: the presence of buildings 16 either improperly situated on parcels or located on parcels 17 of inadequate size and shape in relation to present-day 18 19 standards of development for health and safety and the 20 presence of multiple buildings on a single parcel. For there to be a finding of excessive land coverage, these 21 parcels must exhibit one or more of the following 22 conditions: insufficient provision for light and air 23 24 within or around buildings, increased threat of spread of fire due to the close proximity of buildings, lack of 25 adequate or proper access to a public right-of-way, lack of 26 27 reasonably required off-street parking, or inadequate provision for loading and service. 28

(10) Deleterious land use or layout. The existence of incompatible land-use relationships, buildings occupied by inappropriate mixed-uses, or uses considered to be noxious, offensive, or unsuitable for the surrounding area.

(11) Lack of community planning. The proposed

1 redevelopment project area was developed prior to or 2 without the benefit or guidance of a community plan. This means that the development occurred prior to the adoption 3 4 by the municipality of a comprehensive or other community 5 plan or that the plan was not followed at the time of the area's development. This factor must be documented by 6 7 of adverse incompatible evidence or land-use 8 relationships, inadequate street layout, improper subdivision, parcels of inadequate shape and size to meet 9 contemporary development standards, or other evidence 10 demonstrating an absence of effective community planning. 11

(12) The area has incurred Illinois Environmental 12 Protection United States Environmental 13 Agency or 14 Protection Agency remediation costs for, or a study 15 conducted by an independent consultant recognized as having expertise in environmental remediation has 16 determined a need for, the clean-up of hazardous waste, 17 18 or underground hazardous substances, storage tanks 19 required by State or federal law, provided that the 20 remediation costs constitute a material impediment to the 21 development or redevelopment of the redevelopment project 22 area.

(13) The total equalized assessed value of the proposed 23 24 redevelopment project area has declined for 3 of the last 5 calendar years for which information is available or is 25 26 increasing at an annual rate that is less than the balance of the municipality for 3 of the last 5 calendar years for 27 which information is available or is increasing at an 28 29 annual rate that is less than the Consumer Price Index for 30 All Urban Consumers published by the United States 31 Department of Labor or successor agency for 3 of the last 5 calendar years for which information is available. 32

33 (c) "Industrial park" means an area in a blighted or 34 conservation area suitable for use by any manufacturing,

1 or transportation enterprise, industrial, research of 2 facilities to include but not be limited to factories, mills, 3 plants, assembly plants, processing packing plants, 4 fabricating plants, industrial distribution centers, 5 warehouses, repair overhaul or service facilities, freight terminals, research facilities, test facilities or railroad 6 7 facilities.

8 (d) "Industrial park conservation area" means an area within the boundaries of a redevelopment project area located 9 10 within the territorial limits of a municipality that is a labor 11 surplus municipality or within 1 1/2 miles of the territorial limits of a municipality that is a labor surplus municipality 12 13 if the area is annexed to the municipality; which area is zoned as industrial no later than at the time the municipality by 14 15 ordinance designates the redevelopment project area, and which area includes both vacant land suitable for use as an 16 industrial park and a blighted area or conservation area 17 18 contiguous to such vacant land.

19 (e) "Labor surplus municipality" means a municipality in 20 which, at any time during the 6 months before the municipality 21 by ordinance designates an industrial park conservation area, the unemployment rate was over 6% and was also 100% or more of 22 23 the national average unemployment rate for that same time as 24 published in the United States Department of Labor Bureau of 25 Labor Statistics publication entitled "The Employment 26 Situation" or its successor publication. For the purpose of 27 this subsection, if unemployment rate statistics for the 28 municipality are not available, the unemployment rate in the 29 municipality shall be deemed to be the same as the unemployment 30 rate in the principal county in which the municipality is 31 located.

32 (f) "Municipality" shall mean a city, village or 33 incorporated town.

34

(g) "Initial Sales Tax Amounts" means the amount of taxes

paid under the Retailers' Occupation Tax Act, Use Tax Act, Service Use Tax Act, the Service Occupation Tax Act, the Municipal Retailers' Occupation Tax Act, and the Municipal Service Occupation Tax Act by retailers and servicemen on transactions at places located in a State Sales Tax Boundary during the calendar year 1985.

7 (g-1) "Revised Initial Sales Tax Amounts" means the amount 8 of taxes paid under the Retailers' Occupation Tax Act, Use Tax 9 Act, Service Use Tax Act, the Service Occupation Tax Act, the 10 Municipal Retailers' Occupation Tax Act, and the Municipal 11 Service Occupation Tax Act by retailers and servicemen on 12 transactions at places located within the State Sales Tax 13 Boundary revised pursuant to Section 11-74.4-8a(9) of this Act.

(h) "Municipal Sales Tax Increment" means an amount equal 14 15 to the increase in the aggregate amount of taxes paid to a 16 municipality from the Local Government Tax Fund arising from sales by retailers and servicemen within the redevelopment 17 18 project area or State Sales Tax Boundary, as the case may be, 19 for as long as the redevelopment project area or State Sales 20 Tax Boundary, as the case may be, exist over and above the 21 aggregate amount of taxes as certified by the Illinois Department of Revenue and paid under the Municipal Retailers' 22 23 Occupation Tax Act and the Municipal Service Occupation Tax Act 24 by retailers and servicemen, on transactions at places of 25 business located in the redevelopment project area or State 26 Sales Tax Boundary, as the case may be, during the base year 27 which shall be the calendar year immediately prior to the year 28 in which the municipality adopted tax increment allocation 29 financing. For purposes of computing the aggregate amount of 30 such taxes for base years occurring prior to 1985, the 31 Department of Revenue shall determine the Initial Sales Tax 32 Amounts for such taxes and deduct therefrom an amount equal to 33 4% of the aggregate amount of taxes per year for each year the base year is prior to 1985, but not to exceed a total deduction 34

of 12%. The amount so determined shall be known as the 1 2 "Adjusted Initial Sales Tax Amounts". For purposes of 3 determining the Municipal Sales Tax Increment, the Department 4 of Revenue shall for each period subtract from the amount paid 5 to the municipality from the Local Government Tax Fund arising from sales by retailers and servicemen on transactions located 6 7 in the redevelopment project area or the State Sales Tax 8 Boundary, as the case may be, the certified Initial Sales Tax Amounts, the Adjusted Initial Sales Tax Amounts or the Revised 9 10 Initial Sales Tax Amounts for the Municipal Retailers' Occupation Tax Act and the Municipal Service Occupation Tax 11 Act. For the State Fiscal Year 1989, this calculation shall be 12 made by utilizing the calendar year 1987 to determine the tax 13 14 amounts received. For the State Fiscal Year 1990, this 15 calculation shall be made by utilizing the period from January 1, 1988, until September 30, 1988, to determine the tax amounts 16 17 received from retailers and servicemen pursuant to the 18 Municipal Retailers' Occupation Tax and the Municipal Service which shall have deducted therefrom 19 Occupation Tax Act, 20 nine-twelfths of the certified Initial Sales Tax Amounts, the 21 Adjusted Initial Sales Tax Amounts or the Revised Initial Sales Tax Amounts as appropriate. For the State Fiscal Year 1991, 22 this calculation shall be made by utilizing the period from 23 24 October 1, 1988, to June 30, 1989, to determine the tax amounts 25 received from retailers and servicemen pursuant to the 26 Municipal Retailers' Occupation Tax and the Municipal Service Occupation Tax Act which shall have deducted therefrom 27 28 nine-twelfths of the certified Initial Sales Tax Amounts, 29 Adjusted Initial Sales Tax Amounts or the Revised Initial Sales Tax Amounts as appropriate. For every State Fiscal Year 30 31 thereafter, the applicable period shall be the 12 months 32 beginning July 1 and ending June 30 to determine the tax amounts received which shall have deducted therefrom the 33 certified Initial Sales Tax Amounts, the Adjusted Initial Sales 34

Tax Amounts or the Revised Initial Sales Tax Amounts, as the
 case may be.

3 (i) "Net State Sales Tax Increment" means the sum of the following: (a) 80% of the first \$100,000 of State Sales Tax 4 5 Increment annually generated within a State Sales Tax Boundary; (b) 60% of the amount in excess of \$100,000 but not exceeding 6 7 \$500,000 of State Sales Tax Increment annually generated within a State Sales Tax Boundary; and (c) 40% of all amounts in 8 excess of \$500,000 of State Sales Tax Increment annually 9 10 generated within a State Sales Tax Boundary. If, however, a municipality established a tax increment financing district in 11 a county with a population in excess of 3,000,000 before 12 13 January 1, 1986, and the municipality entered into a contract 14 or issued bonds after January 1, 1986, but before December 31, 15 1986, to finance redevelopment project costs within a State Sales Tax Boundary, then the Net State Sales Tax Increment 16 means, for the fiscal years beginning July 1, 1990, and July 1, 17 18 1991, 100% of the State Sales Tax Increment annually generated 19 within a State Sales Tax Boundary; and notwithstanding any 20 other provision of this Act, for those fiscal years the 21 Department of Revenue shall distribute to those municipalities 100% of their Net State Sales Tax Increment before any 22 distribution to any other municipality and regardless of 23 whether or not those other municipalities will receive 100% of 24 25 their Net State Sales Tax Increment. For Fiscal Year 1999, and 26 every year thereafter until the year 2007, for any municipality that has not entered into a contract or has not issued bonds 27 28 prior to June 1, 1988 to finance redevelopment project costs 29 within a State Sales Tax Boundary, the Net State Sales Tax 30 Increment shall be calculated as follows: By multiplying the 31 Net State Sales Tax Increment by 90% in the State Fiscal Year 1999; 80% in the State Fiscal Year 2000; 70% in the State 32 Fiscal Year 2001; 60% in the State Fiscal Year 2002; 50% in the 33 State Fiscal Year 2003; 40% in the State Fiscal Year 2004; 30% 34

in the State Fiscal Year 2005; 20% in the State Fiscal Year
 2006; and 10% in the State Fiscal Year 2007. No payment shall
 be made for State Fiscal Year 2008 and thereafter.

4 Municipalities that issued bonds in connection with a 5 redevelopment project in a redevelopment project area within the State Sales Tax Boundary prior to July 29, 1991, or that 6 7 entered into contracts in connection with a redevelopment project in a redevelopment project area before June 1, 1988, 8 shall continue to receive their proportional share of the 9 10 Illinois Tax Increment Fund distribution until the date on which the redevelopment project is completed or terminated. If, 11 however, a municipality that issued bonds in connection with a 12 redevelopment project in a redevelopment project area within 13 14 the State Sales Tax Boundary prior to July 29, 1991 retires the 15 bonds prior to June 30, 2007 or a municipality that entered 16 into contracts in connection with a redevelopment project in a 17 redevelopment project area before June 1, 1988 completes the 18 contracts prior to June 30, 2007, then so long as the 19 redevelopment project is not completed or is not terminated, 20 the Net State Sales Tax Increment shall be calculated, 21 beginning on the date on which the bonds are retired or the contracts are completed, as follows: By multiplying the Net 22 State Sales Tax Increment by 60% in the State Fiscal Year 2002; 23 24 50% in the State Fiscal Year 2003; 40% in the State Fiscal Year 25 2004; 30% in the State Fiscal Year 2005; 20% in the State 26 Fiscal Year 2006; and 10% in the State Fiscal Year 2007. No payment shall be made for State Fiscal Year 2008 and 27 28 thereafter. Refunding of any bonds issued prior to July 29, 29 1991, shall not alter the Net State Sales Tax Increment.

30 (j) "State Utility Tax Increment Amount" means an amount 31 equal to the aggregate increase in State electric and gas tax 32 charges imposed on owners and tenants, other than residential 33 customers, of properties located within the redevelopment 34 project area under Section 9-222 of the Public Utilities Act,

over and above the aggregate of such charges as certified by 1 the Department of Revenue and paid by owners and tenants, other 2 3 residential customers, of properties within the than 4 redevelopment project area during the base year, which shall be 5 the calendar year immediately prior to the year of the adoption 6 of the ordinance authorizing tax increment allocation 7 financing.

8 (k) "Net State Utility Tax Increment" means the sum of the following: (a) 80% of the first \$100,000 of State Utility Tax 9 Increment annually generated by a redevelopment project area; 10 (b) 60% of the amount in excess of \$100,000 but not exceeding 11 \$500,000 of the State Utility Tax Increment annually generated 12 13 by a redevelopment project area; and (c) 40% of all amounts in excess of \$500,000 of State Utility Tax Increment annually 14 15 generated by a redevelopment project area. For the State Fiscal 16 Year 1999, and every year thereafter until the year 2007, for any municipality that has not entered into a contract or has 17 18 not issued bonds prior to June 1, 1988 to finance redevelopment 19 project costs within a redevelopment project area, the Net 20 State Utility Tax Increment shall be calculated as follows: By 21 multiplying the Net State Utility Tax Increment by 90% in the State Fiscal Year 1999; 80% in the State Fiscal Year 2000; 70% 22 in the State Fiscal Year 2001; 60% in the State Fiscal Year 23 24 2002; 50% in the State Fiscal Year 2003; 40% in the State 25 Fiscal Year 2004; 30% in the State Fiscal Year 2005; 20% in the 26 State Fiscal Year 2006; and 10% in the State Fiscal Year 2007. 29 Municipalities that issue bonds in connection with the 30 redevelopment project during the period from June 1, 1988 until 31 3 years after the effective date of this Amendatory Act of 1988 32 shall receive the Net State Utility Tax Increment, subject to 33 appropriation, for 15 State Fiscal Years after the issuance of 34 such bonds. (m) "Payment in lieu of taxes" means those estimated tax 12 13 revenues from real property in a redevelopment project area derived from real property that has been acquired by a 14 15 municipality which according to the redevelopment project or plan is to be used for a private use which taxing districts 16 17 would have received had a municipality not acquired the real 18 property and adopted tax increment allocation financing and 19 which would result from levies made after the time of the 20 adoption of tax increment allocation financing to the time the 21 current equalized value of real property in the redevelopment project area exceeds the total initial equalized value of real 22 23 property in said area.

(n) "Redevelopment plan" means the comprehensive program 24 25 of the municipality for development or redevelopment intended 26 by the payment of redevelopment project costs to reduce or 27 eliminate those conditions the existence of which qualified the 28 "blighted redevelopment project area as а area" or "conservation area" or combination thereof or "industrial park 29 30 conservation area," and thereby to enhance the tax bases of the 31 taxing districts which extend into the redevelopment project area. On and after November 1, 1999 (the effective date of 32 33 Public Act 91-478), no redevelopment plan may be approved or amended that includes the development of vacant land (i) with a 34

golf course and related clubhouse and other facilities or (ii) 1 designated by federal, State, county, or municipal government 2 3 as public land for outdoor recreational activities or for 4 nature preserves and used for that purpose within 5 years prior 5 to the adoption of the redevelopment plan. For the purpose of this subsection, "recreational activities" is limited to mean 6 camping and hunting. Each redevelopment plan shall set forth in 7 8 writing the program to be undertaken to accomplish the objectives and shall include but not be limited to: 9

10 (A) an itemized list of estimated redevelopment

28 (H) a commitment to fair employment practices and an
29 affirmative action plan;

(I) if it concerns an industrial park conservation
area, the plan shall also include a general description of
any proposed developer, user and tenant of any property, a
description of the type, structure and general character of
the facilities to be developed, a description of the type,

1 2 class and number of new employees to be employed in the operation of the facilities to be developed; and

3 (J) if property is to be annexed to the municipality, 4 the plan shall include the terms of the annexation 5 agreement.

The provisions of items (B) and (C) of this subsection (n) 6 7 shall not apply to a municipality that before March 14, 1994 8 (the effective date of Public Act 88-537) had fixed, either by 9 its corporate authorities or by a commission designated under subsection (k) of Section 11-74.4-4, a time and place for a 10 public hearing as required by subsection (a) of Section 11 11-74.4-5. Belleville, or 1 (X) if the ordinance was adopted on December 29, 2 1986 by the City of Collinsville, or 3 4 (Y) if the ordinance was adopted on September 14, 5 1994 by the City of Alton, or (Z) if the ordinance was adopted on November 11, 6 7 1996 by the City of Lexington, or 8 (AA) if the ordinance was adopted on November 5, 1984 by the City of LeRoy, or 9 (BB) if the ordinance was adopted on April 3, 1991 10 or June 3, 1992 by the City of Markham, or-11 (CC) if the ordinance was adopted on January 19, 12 1988 by the City of Waukegan, or 13 (DD) if the ordinance was adopted on September 21, 14 15 1998 by the City of Waukegan, or (EE) if the ordinance was adopted on December 15, 16 1981 by the City of Champaign, or 17 (FF) if the ordinance was adopted on December 15, 18 1986 by the City of Urbana, or 19 20 (GG) if the ordinance was adopted on December 31, 21 1986 by the Village of Milan, or 22 (HH) if the ordinance was adopted on November 30, 23 1986 by the City of Effingham, or 24 (II) if the ordinance was adopted on May 20, 1985 25 by the Village of Wheeling. 26 However, for redevelopment project areas for which bonds were issued before July 29, 1991, or for which 27 28 contracts were entered into before June 1, 1988, in 29 connection with a redevelopment project in the area within the State Sales Tax Boundary, the estimated dates of 30 31 completion of the redevelopment project and retirement of 32 obligations to finance redevelopment project costs may be 33 extended by municipal ordinance to December 31, 2013. The termination procedures of subsection (b) of Section 34

1 11-74.4-8 are not required for these redevelopment project 2 areas in 2009 but are required in 2013. The extension 3 allowed by this amendatory Act of 1993 shall not apply to 4 real property tax increment allocation financing under 5 Section 11-74.4-8.

A municipality may by municipal ordinance amend an 6 7 existing redevelopment plan to conform to this paragraph 8 (3) as amended by Public Act 91-478, which municipal ordinance may be adopted without further hearing or notice 9 and without complying with the procedures provided in this 10 Act pertaining to an amendment to or the initial approval 11 of a redevelopment plan and project and designation of a 12 redevelopment project area. 13

Those dates, for purposes of real property tax 14 15 increment allocation financing pursuant to Section 11-74.4-8 only, shall be not more than 35 years for 16 redevelopment project areas that were adopted on or after 17 18 December 16, 1986 and for which at least \$8 million worth 19 of municipal bonds were authorized on or after December 19, 20 1989 but before January 1, 1990; provided that the 21 municipality elects to extend the life of the redevelopment project area to 35 years by the adoption of an ordinance 22 after at least 14 but not more than 30 days' written notice 23 24 to the taxing bodies, that would otherwise constitute the joint review board for the redevelopment project area, 25 26 before the adoption of the ordinance.

27 Those dates, for purposes of real property tax 28 increment allocation financing pursuant to Section 29 11-74.4-8 only, shall be not more than 35 years for 30 redevelopment project areas that were established on or 31 after December 1, 1981 but before January 1, 1982 and for which at least \$1,500,000 worth of tax increment revenue 32 bonds were authorized on or after September 30, 1990 but 33 before July 1, 1991; provided that the municipality elects 34

to extend the life of the redevelopment project area to 35 years by the adoption of an ordinance after at least 14 but not more than 30 days' written notice to the taxing bodies, that would otherwise constitute the joint review board for the redevelopment project area, before the adoption of the ordinance.

(3.5) The municipality finds, in the case of an 7 8 industrial park conservation area, also that the 9 municipality is a labor surplus municipality and that the implementation of the redevelopment plan will reduce 10 unemployment, create new jobs and by the provision of new 11 facilities enhance the tax base of the taxing districts 12 that extend into the redevelopment project area. 13

(4) If any incremental revenues are being utilized 14 15 under Section 8(a)(1) or 8(a)(2) of this Act in redevelopment project areas approved by ordinance after 16 January 1, 1986, the municipality finds: (a) that the 17 18 redevelopment project area would not reasonably be 19 developed without the use of such incremental revenues, and 20 (b) that such incremental revenues will be exclusively 21 utilized for the development of the redevelopment project 22 area.

If the redevelopment plan will not result in 23 (5) 24 displacement of residents from 10 or more inhabited residential units, and the municipality certifies in the 25 26 plan that such displacement will not result from the plan, 27 a housing impact study need not be performed. If, however, the redevelopment plan would result in the displacement of 28 29 residents from 10 or more inhabited residential units, or 30 if the redevelopment project area contains 75 or more 31 inhabited residential units and no certification is made, then the municipality shall prepare, as part of the 32 separate feasibility report required by subsection (a) of 33 Section 11-74.4-5, a housing impact study. 34

Part I of the housing impact study shall include (i) 1 data as to whether the residential units are single family 2 or multi-family units, (ii) the number and type of rooms 3 4 within the units, if that information is available, (iii) 5 whether the units are inhabited or uninhabited, as determined not less than 45 days before the date that the 6 ordinance or resolution required by subsection (a) of 7 8 Section 11-74.4-5 is passed, and (iv) data as to the racial and ethnic composition of the residents in the inhabited 9 residential units. The data requirement as to the racial 10 and ethnic composition of the residents in the inhabited 11 residential units shall be deemed to be fully satisfied by 12 data from the most recent federal census. 13

Part II of the housing impact study shall identify the 14 15 inhabited residential units in the proposed redevelopment project area that are to be or may be removed. If inhabited 16 residential units are to be removed, then the housing 17 18 impact study shall identify (i) the number and location of 19 those units that will or may be removed, (ii) the 20 municipality's plans for relocation assistance for those 21 residents in the proposed redevelopment project area whose residences are to be removed, (iii) the availability of 22 replacement housing for those residents whose residences 23 24 are to be removed, and shall identify the type, location, and cost of the housing, and (iv) the type and extent of 25 26 relocation assistance to be provided.

(6) On and after November 1, 1999, the housing impact study required by paragraph (5) shall be incorporated in the redevelopment plan for the redevelopment project area.

30 (7) On and after November 1, 1999, no redevelopment 31 plan shall be adopted, nor an existing plan amended, nor 32 shall residential housing that is occupied by households of 33 low-income and very low-income persons in currently 34 existing redevelopment project areas be removed after

November 1, 1999 unless the redevelopment plan provides, 1 2 with respect to inhabited housing units that are to be removed for households of low-income and very low-income 3 4 persons, affordable housing and relocation assistance not 5 less than that which would be provided under the federal Relocation Assistance 6 Uniform and Real Property 7 Acquisition Policies Act of 1970 and the regulations under 8 that Act, including the eligibility criteria. Affordable 9 housing may be either existing or newly constructed housing. For purposes of this paragraph (7), "low-income 10 households", "very low-income households", and "affordable 11 housing" have the meanings set forth in the Illinois 12 Affordable Housing Act. The municipality shall make a good 13 faith effort to ensure that this affordable housing is 14 15 located in or near the redevelopment project area within the municipality. 16

(8) On and after November 1, 1999, if, after the adoption of the redevelopment plan for the redevelopment project area, any municipality desires to amend its redevelopment plan to remove more inhabited residential units than specified in its original redevelopment plan, that change shall be made in accordance with the procedures in subsection (c) of Section 11-74.4-5.

24 (9) For redevelopment project areas designated prior to November 1, 1999, the redevelopment plan may be amended 25 26 without further joint review board meeting or hearing, 27 provided that the municipality shall give notice of any such changes by mail to each affected taxing district and 28 29 registrant on the interested party registry, to authorize 30 the municipality to expend tax increment revenues for 31 redevelopment project costs defined by paragraphs (5) and (7.5), subparagraphs (E) and (F) of paragraph (11), and 32 paragraph (11.5) of subsection (q) of Section 11-74.4-3, so 33 long as the changes do not increase the total estimated 34

redevelopment project costs set out in the redevelopment plan by more than 5% after adjustment for inflation from the date the plan was adopted.

(o) "Redevelopment project" means any public and private 4 5 development project in furtherance of the objectives of a redevelopment plan. On and after November 1, 1999 (the 6 7 effective date of Public Act 91-478), no redevelopment plan may 8 be approved or amended that includes the development of vacant land (i) with a golf course and related clubhouse and other 9 facilities or (ii) designated by federal, State, county, or 10 11 municipal government as public land for outdoor recreational activities or for nature preserves and used for that purpose 12 13 within 5 years prior to the adoption of the redevelopment plan. For the purpose of this subsection, "recreational activities" 14 15 is limited to mean camping and hunting.

(p) "Redevelopment project area" means an area designated by the municipality, which is not less in the aggregate than 1 1/2 acres and in respect to which the municipality has made a finding that there exist conditions which cause the area to be classified as an industrial park conservation area or a blighted area or a conservation area, or a combination of both blighted areas and conservation areas.

(q) "Redevelopment project costs" mean and include the sum total of all reasonable or necessary costs incurred or estimated to be incurred, and any such costs incidental to a redevelopment plan and a redevelopment project. Such costs include, without limitation, the following:

(1) Costs of studies, surveys, development of plans,
and specifications, implementation and administration of
the redevelopment plan including but not limited to staff
and professional service costs for architectural,
engineering, legal, financial, planning or other services,
provided however that no charges for professional services
may be based on a percentage of the tax increment

1 collected; except that on and after November 1, 1999 (the effective date of Public Act 91-478), no contracts for 2 excluding architectural 3 professional services, and 4 engineering services, may be entered into if the terms of 5 the contract extend beyond a period of 3 years. In addition, "redevelopment project costs" shall not include 6 After consultation 7 lobbying expenses. with the 8 municipality, each tax increment consultant or advisor to a 9 municipality that plans to designate or has designated a redevelopment project area shall inform the municipality 10 in writing of any contracts that the consultant or advisor 11 has entered into with entities or individuals that have 12 received, or are receiving, payments financed by tax 13 increment revenues produced by the redevelopment project 14 15 area with respect to which the consultant or advisor has performed, or will be performing, service for 16 the municipality. This requirement shall be satisfied by the 17 18 consultant or advisor before the commencement of services 19 for the municipality and thereafter whenever any other 20 contracts with those individuals or entities are executed 21 by the consultant or advisor;

(1.5) After July 1, 1999, annual administrative costs shall not include general overhead or administrative costs of the municipality that would still have been incurred by the municipality if the municipality had not designated a redevelopment project area or approved a redevelopment plan;

(1.6) The cost of marketing sites within the
redevelopment project area to prospective businesses,
developers, and investors;

(2) Property assembly costs, including but not limited
 to acquisition of land and other property, real or
 personal, or rights or interests therein, demolition of
 buildings, site preparation, site improvements that serve

as an engineered barrier addressing ground level or below ground environmental contamination, including, but not limited to parking lots and other concrete or asphalt barriers, and the clearing and grading of land;

5 (3) Costs of rehabilitation, reconstruction or repair or remodeling of existing public or private buildings, 6 7 fixtures, and leasehold improvements; and the cost of 8 replacing an existing public building if pursuant to the implementation of a redevelopment project the existing 9 public building is to be demolished to use the site for 10 private investment or devoted to a different use requiring 11 private investment; 12

13 (4) Costs of the construction of public works or improvements, except that on and after November 1, 1999, 14 15 redevelopment project costs shall not include the cost of constructing a new municipal public building principally 16 used to provide offices, storage space, or conference 17 18 facilities or vehicle storage, maintenance, or repair for 19 administrative, public safety, or public works personnel 20 and that is not intended to replace an existing public 21 building as provided under paragraph (3) of subsection (q) of Section 11-74.4-3 unless either (i) the construction of 22 23 the new municipal building implements a redevelopment 24 project that was included in a redevelopment plan that was 25 adopted by the municipality prior to November 1, 1999 or 26 (ii) the municipality makes a reasonable determination in 27 redevelopment plan, supported by information that the 28 provides the basis for that determination, that the new 29 municipal building is required to meet an increase in the 30 need for public safety purposes anticipated to result from 31 the implementation of the redevelopment plan;

32 (5) Costs of job training and retraining projects,
 33 including the cost of "welfare to work" programs
 34 implemented by businesses located within the redevelopment

1 project area;

(6) Financing costs, including but not limited to all 2 necessary and incidental expenses related to the issuance 3 4 of obligations and which may include payment of interest on 5 any obligations issued hereunder including interest accruing during the estimated period of construction of any 6 7 redevelopment project for which such obligations are 8 issued and for not exceeding 36 months thereafter and including reasonable reserves related thereto; 9

10 (7) To the extent the municipality by written agreement 11 accepts and approves the same, all or a portion of a taxing 12 district's capital costs resulting from the redevelopment 13 project necessarily incurred or to be incurred within a 14 taxing district in furtherance of the objectives of the 15 redevelopment plan and project.

(7.5) For redevelopment project areas designated (or 16 redevelopment project areas amended to add or increase the 17 18 number of tax-increment-financing assisted housing units) 19 on or after November 1, 1999, an elementary, secondary, or 20 unit school district's increased costs attributable to 21 assisted housing units located within the redevelopment 22 project area for which the developer or redeveloper receives financial assistance through an agreement with 23 24 the municipality or because the municipality incurs the 25 cost of necessary infrastructure improvements within the 26 boundaries of the assisted housing sites necessary for the 27 completion of that housing as authorized by this Act, and which costs shall be paid by the municipality from the 28 29 Special Tax Allocation Fund when the tax increment revenue 30 is received as a result of the assisted housing units and 31 shall be calculated annually as follows:

32 (A) for foundation districts, excluding any school
33 district in a municipality with a population in excess
34 of 1,000,000, by multiplying the district's increase

(i) for unit school districts with a district average 1995-96 Per Capita Tuition Charge of less than \$5,900, no more than 25% of the total amount of property tax increment revenue produced by those housing units that have received tax increment finance assistance under this Act;

(ii) for elementary school districts with a district average 1995-96 Per Capita Tuition Charge of less than \$5,900, no more than 17% of the total amount of property tax increment revenue produced by those housing units that have received tax increment finance assistance under this Act; and

(iii) for secondary school districts with a
district average 1995-96 Per Capita Tuition Charge
of less than \$5,900, no more than 8% of the total
amount of property tax increment revenue produced
by those housing units that have received tax
increment finance assistance under this Act.
(B) For alternate method districts, flat grant

districts, and foundation districts with a district 1 average 1995-96 Per Capita Tuition Charge equal to or 2 more than \$5,900, excluding any school district with a 3 4 population in excess of 1,000,000, by multiplying the 5 district's increase in attendance resulting from the net increase in new students enrolled in that school 6 district who reside in housing units within the 7 8 redevelopment project area that have received 9 financial assistance through an agreement with the municipality or because the municipality incurs the 10 cost of necessary infrastructure improvements within 11 the boundaries of the housing sites necessary for the 12 13 completion of that housing as authorized by this Act since the designation of the redevelopment project 14 15 area by the most recently available per capita tuition cost as defined in Section 10-20.12a of the School Code 16 less any increase in general state aid as defined in 17 18 Section 18-8.05 of the School Code attributable to 19 these added new students subject to the following 20 annual limitations:

assistance under this Act.

(C) For any school district in a municipality with a population in excess of 1,000,000, the following restrictions shall apply to the reimbursement of increased costs under this paragraph (7.5):

(i) no increased costs shall be reimbursed unless the school district certifies that each of the schools affected by the assisted housing project is at or over its student capacity;

(ii) the amount reimburseable shall be reduced by the value of any land donated to the school district by the municipality or developer, and by the value of any physical improvements made to the schools by the municipality or developer; and

(iii) the amount reimbursed may not affect
amounts otherwise obligated by the terms of any
bonds, notes, or other funding instruments, or the
terms of any redevelopment agreement.

(9) Payment in lieu of taxes;

"State Sales Tax Boundary" means the redevelopment 24 (r)25 area or the amended redevelopment project area project 26 boundaries which are determined pursuant to subsection (9) of Section 11-74.4-8a of this Act. The Department of Revenue shall 27 28 certify pursuant to subsection (9) of Section 11-74.4-8a the 29 appropriate boundaries eligible for the determination of State 30 Sales Tax Increment.

31 (s) "State Sales Tax Increment" means an amount equal to 32 the increase in the aggregate amount of taxes paid by retailers 33 and servicemen, other than retailers and servicemen subject to 34 the Public Utilities Act, on transactions at places of business

(t) "Taxing districts" means counties, townships, cities and incorporated towns and villages, school, road, park, sanitary, mosquito abatement, forest preserve, public health, fire protection, river conservancy, tuberculosis sanitarium and any other municipal corporations or districts with the power to levy taxes.

31 (u) "Taxing districts' capital costs" means those costs of 32 taxing districts for capital improvements that are found by the 33 municipal corporate authorities to be necessary and directly 34 result from the redevelopment project.

Obligations secured by the special tax allocation fund set forth in Section 11-74.4-8 for 5 the redevelopment project area may be issued to provide 6 for 7 redevelopment project costs. Such obligations, when so issued, shall be retired in the manner provided in the ordinance 8 9 authorizing the issuance of such obligations by the receipts of taxes levied as specified in Section 11-74.4-9 against the 10 taxable property included in the area, by revenues as specified 11 by Section 11-74.4-8a and other revenue designated by the 12 13 municipality. A municipality may in the ordinance pledge all or 14 any part of the funds in and to be deposited in the special tax allocation fund created pursuant to Section 11-74.4-8 to the 15 payment of the redevelopment project costs and obligations. Any 16 17 pledge of funds in the special tax allocation fund shall 18 provide for distribution to the taxing districts and to the 19 Illinois Department of Revenue of moneys not required, pledged, 20 earmarked, or otherwise designated for payment and securing of the obligations and anticipated redevelopment project costs 21 22 and such excess funds shall be calculated annually and deemed to be "surplus" funds. In the event a municipality only applies 23 24 or pledges a portion of the funds in the special tax allocation 25 fund for the payment or securing of anticipated redevelopment project costs or of obligations, any such funds remaining in 26 27 the special tax allocation fund after complying with the 28 requirements of the application or pledge, shall also be calculated annually and deemed "surplus" funds. All surplus 29 30 funds in the special tax allocation fund shall be distributed 31 annually within 180 days after the close of the municipality's 32 fiscal year by being paid by the municipal treasurer to the County Collector, to the Department of Revenue and to the 33

1 municipality in direct proportion to the tax incremental 2 revenue received as a result of an increase in the equalized 3 assessed value of property in the redevelopment project area, 4 tax incremental revenue received from the State and tax 5 incremental revenue received from the municipality, but not to exceed as to each such source the total incremental revenue 6 7 received from that source. 13 Without limiting the foregoing in this Section, the municipality may in addition to obligations secured by the 14 15 special tax allocation fund pledge for a period not greater 16 than the term of the obligations towards payment of such obligations any part or any combination of the following: (a) 17 18 net revenues of all or part of any redevelopment project; (b) 19 taxes levied and collected on any or all property in the 20 municipality; (C) the full faith and credit of the 21 a mortgage on part or all municipality; (d) of the 22 redevelopment project; or (e) any other taxes or anticipated 23 receipts that the municipality may lawfully pledge.

24 Such obligations may be issued in one or more series 25 bearing interest at such rate or rates as the corporate 26 authorities of the municipality shall determine by ordinance. 5 In the event the municipality authorizes issuance of obligations pursuant to the authority of this Division secured 6 7 by the full faith and credit of the municipality, which 8 obligations are other than obligations which may be issued under home rule powers provided by Article VII, Section 6 of 9 the Illinois Constitution, or pledges taxes pursuant to (b) or 10 (c) of the second paragraph of this section, the ordinance 11 authorizing the issuance of such obligations or pledging such 12 13 taxes shall be published within 10 days after such ordinance 14 has been passed in one or more newspapers, with general 15 circulation within such municipality. The publication of the ordinance shall be accompanied by a notice of (1) the specific 16 17 number of voters required to sign a petition requesting the 18 question of the issuance of such obligations or pledging taxes 19 to be submitted to the electors; (2) the time in which such 20 petition must be filed; and (3) the date of the prospective 21 referendum. The municipal clerk shall provide a petition form to any individual requesting one. 22

municipality under the authority of this Act, whether at or 1 2 prior to maturity, provided however, that the last maturity of 3 the refunding obligations shall not be expressed to mature 4 later than December 31 of the year in which the payment to the 5 municipal treasurer as provided in subsection (b) of Section 11-74.4-8 of this Act is to be made with respect to ad valorem 6 7 taxes levied in the twenty-third calendar year after the year 8 in which the ordinance approving the redevelopment project area is adopted if the ordinance was adopted on or after January 15, 9 10 1981, and not later than December 31 of the year in which the payment to the municipal treasurer as provided in subsection 11 (b) of Section 11-74.4-8 of this Act is to be made with respect 12 13 to ad valorem taxes levied in the thirty-fifth calendar year year in which the ordinance approving the 14 after the 15 redevelopment project area is adopted (A) if the ordinance was adopted before January 15, 1981, or (B) if the ordinance was 16 17 adopted in December 1983, April 1984, July 1985, or December 18 1989, or (C) if the ordinance was adopted in December, 1987 and the redevelopment project is located within one mile of Midway 19 20 Airport, or (D) if the ordinance was adopted before January 1, 21 1987 by a municipality in Mason County, or (E) if the municipality is subject to the Local Government Financial 22 23 Planning and Supervision Act or the Financially Distressed City 24 Law, or (F) if the ordinance was adopted in December 1984 by 25 the Village of Rosemont, or (G) if the ordinance was adopted on 26 December 31, 1986 by a municipality located in Clinton County for which at least \$250,000 of tax increment bonds were 27 28 authorized on June 17, 1997, or if the ordinance was adopted on 29 December 31, 1986 by a municipality with a population in 1990 of less than 3,600 that is located in a county with a 30 31 population in 1990 of less than 34,000 and for which at least 32 \$250,000 of tax increment bonds were authorized on June 17, 33 1997, or (H) if the ordinance was adopted on October 5, 1982 by the City of Kankakee, or (I) if the ordinance was adopted on 34

1986 by the Village of Milan, or (HH) if the ordinance was 1 adopted on November 30, 1986 by the City of Effingham, or (II) 2 3 if the ordinance was adopted on May 20, 1985 by the Village of 4 Wheeling and, for redevelopment project areas for which bonds 5 were issued before July 29, 1991, in connection with a redevelopment project in the area within the State Sales Tax 6 7 Boundary and which were extended by municipal ordinance under subsection (n) of Section 11-74.4-3, the last maturity of the 8 refunding obligations shall not be expressed to mature later 9 10 than the date on which the redevelopment project area is terminated or December 31, 2013, whichever date occurs first. 11

In the event a municipality issues obligations under home 12 rule powers or other legislative authority the proceeds of 13 which are pledged to pay for redevelopment project costs, the 14 15 municipality may, if it has followed the procedures in conformance with this division, retire said obligations from 16 17 funds in the special tax allocation fund in amounts and in such 18 manner as if such obligations had been issued pursuant to the 19 provisions of this division.

All obligations heretofore or hereafter issued pursuant to this Act shall not be regarded as indebtedness of the municipality issuing such obligations or any other taxing district for the purpose of any limitation imposed by law.
