**SYNOPSIS AS INTRODUCED:**

625 ILCS 5/3-806.3

from Ch. 95 1/2, par. 3-806.3

Amends the Illinois Vehicle Code. Provides that, commencing with the 2006 registration year, a person who has claimed and received a grant under the Senior Citizens and Disabled Persons Property Relief and Pharmaceutical Assistance Act, or the spouse of one of those persons, shall be charged \$24, instead of the usual registration fee, for a vehicle displaying the license plates issued to Gold Star recipients.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Illinois Vehicle Code is amended by changing  
5 Section 3-806.3 as follows:

4 Section 3-815(b). Widows and widowers of claimants shall also  
5 be entitled to this reduced registration fee for the  
6 registration year in which the claimant was eligible.

7 Commencing with the 2006 registration year, the  
8 registration fee paid by any vehicle owner who has claimed and  
9 received a grant under the Senior Citizens and Disabled Persons  
10 Property Tax Relief and Pharmaceutical Assistance Act or who is  
11 the spouse of such a person shall be \$24 instead of the fee  
12 otherwise provided in this Code for passenger cars displaying  
13 standard multi-year registration plates issued under Section  
14 3-414.1, motor vehicles displaying special registration plates  
15 issued under Section 3-616, 3-621, 3-622, 3-623, 3-624, 3-625,  
16 3-626, 3-628, 3-638, 3-642, 3-645, 3-647, 3-650, 3-651, or  
17 3-806.4, motor vehicles registered at 8,000 pounds or less  
18 under Section 3-815(a), and recreational vehicles registered  
19 at 8,000 pounds or less under Section 3-815(b). Widows and  
20 widowers of claimants shall also be entitled to this reduced  
21 registration fee for the registration year in which the  
22 claimant was eligible.

23 No more than one reduced registration fee under this  
24 Section shall be allowed during any 12 month period based on  
25 the primary eligibility of any individual, whether such reduced  
26 registration fee is allowed to the individual or to the spouse,  
27 widow or widower of such individual. This Section does not  
28 apply to the fee paid in addition to the registration fee for  
29 motor vehicles displaying vanity or special license plates.
