Makes appropriations and reappropriations to Southern Illinois University for various purposes, including ordinary and contingent expenses. Effective July 1, 2004.

A BILL FOR

1 AN ACT making appropriations and reappropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 Section 5. The following named sums, or so much thereof
5 as may be necessary, respectively, for the objects and
6 purposes hereinafter named, are appropriated from the General
7 Revenue Fund to the Board of Trustees of Southern Illinois
8 University to meet the ordinary and contingent expenses of
9 Southern Illinois University, including payment or
10 reimbursement to the University for personal services and
11 related costs, incurred during the fiscal year ending June
12 30, 2005:

14	for personal services costs incurred during the fiscal

16	For State Contributions to Social	
17	Security, for Medicare	2,445,200

29 Section 10. The sum of \$250,000, or so much thereof as
30 may be necessary, is appropriated from the General Revenue
31 Fund to the Board of Trustees of Southern Illinois University
32 for all costs required to match the Federal Title II Teacher

1 Quality Enhancement State Grant for Southern Illinois
2 University-Carbondale, including payment to the University
3 for personal services and related costs incurred, for the
4 fiscal year ending June 30, 2005.

6 Section 15. The sum of \$250,000, or so much thereof as
7 may be necessary, is appropriated from the General Revenue
8 Fund to the Board of Trustees of Southern Illinois University
9 for all costs required to match the Federal Title II Teacher
10 Quality Enhancement State Grant for Southern Illinois
11 University-Edwardsville, including payment to the University
12 for personal services and related costs incurred, for the
13 fiscal year ending June 30, 2005.

15 Section 20. The sum of \$800,000, or so much thereof as
16 may be necessary and remains unexpended at the close of
17 business on June 30, 2004, from a reappropriation heretofore
18 made for such purpose in Article 4, Section 65 of Public Act
19 93-587, is reappropriated from the Capital Development Fund
20 to the Board of Trustees of Southern Illinois University for
21 the purchase of equipment for Altgeld Hall and the Old
22 Baptist Foundation Building at Southern Illinois University-
23 Carbondale.

24 Section 99. Effective date. This Act takes effect July 1,
25 2004.
