SYNOPSIS AS INTRODUCED:

35 ILCS 200/9-230

Amends the Property Tax Code. In a provision allowing the county board to submit a bill to the township board of trustees for the reasonable costs incurred by the supervisor of assessments in completing certain assessments, provides that the moneys collected from the billing may be used by the supervisor of assessments only for the purpose of recouping costs incurred in completing the assessments. Effective immediately.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Property Tax Code is amended by changing
Section 9-230 as follows:

6 (35 ILCS 200/9-230)

Sec. 9-230. Return of township or multi-township
assessment books.

(a) The township or multi-township assessors in counties 9 with less than 600,000 inhabitants, based on the 2000 federal 10 decennial census, shall, on or before April 15 of the 11 assessment year, return the assessment books or workbooks to 12 the supervisor of assessments. The township or multi-township 13 14 assessors in counties with 600,000 or more but no more than 15 700,000 inhabitants, based on the 2000 federal decennial census, shall, on or before October 15 of the assessment year, 16 17 return the assessment books or workbooks to the supervisor of assessments. The township or multi-township assessors in 18 19 counties with less than 3,000,000 inhabitants, but more than 700,000 inhabitants, based on the 2000 federal decennial 20 census, shall, on or before November 15 of the assessment year, 21 22 return the assessment books or workbooks to the supervisor of 23 assessments. If a township or multi-township assessor in a county with less than 3,000,000 inhabitants, but more than 24 25 600,000 inhabitants, based on the 2000 federal decennial 26 census, does not return the assessment books or work books within the required time, the supervisor of assessments may 27 28 take possession of the books and complete the assessments pursuant to law. Each of the books shall be verified by 29 30 affidavit by the assessor substantially as follows: State of Illinois) 31

3 I do solemnly swear that the book or books in number, 4 to which this affidavit is attached, contains a complete list 5 of all of the property in the township or multi-township or assessment district herein described subject to taxation for 6 7 the year so far as I have been able to ascertain, and that 8 the assessed value set down in the proper column opposite the descriptions of property is a just and equal assessment of the 9 property according to law. 10

(b) If the supervisor of assessments determines that the 12 13 township or multi-township assessor has not completed the assessments as required by law before returning the assessment 14 15 books under this Section, the county board may submit a bill to 16 the township board of trustees for the reasonable costs 17 incurred by the supervisor of assessments in completing the assessments. The moneys collected under this subsection may be 18 used by the supervisor of assessments only for the purpose of 19 20 recouping costs incurred in completing the assessments.
