1 AN ACT concerning appropriations.

# Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

5 Section 5. The following named amounts, or so much thereof as may be necessary, respectively, for the objects 6 and purposes hereinafter named, are appropriated to the Board 7 8 of the Trustees of the University of Illinois to meet ordinary and contingent expenses for the fiscal year ending 9 10 June 30, 2006: Payable from the General Revenue Fund: 11 For Personal Services, including payment 12 to the university for personal services 13 costs incurred during the fiscal year 14 and salaries accrued but unpaid to academic 15 personnel for personal services rendered 16 during the academic year 2005-2006 ...........610,104,800 17 For State Contributions to Social 18 19 20 21 22 23 24 For Telecommunications Services .................5,028,800 2.5 For Operation of Automotive Equipment ......967,000 2.6 27 28 For Distributive Purposes as follows: For Awards and Grants ......5,907,500 29 For Claims under Workers' Compensation 30

Section 10. The sum of \$1,988,500, or so much thereof as 5 may be necessary, is appropriated from the Fire Prevention 6 Fund to the Board of Trustees of the University of Illinois 7 for the purpose of maintaining the Illinois Fire Service 8 Institute, paying the Institute's expenses, and providing the 9 10 facilities and structures incident thereto, including payment to the University for personal services and related costs 11 12 incurred.

Section 15. The sum of \$250,000, or so much thereof as may be necessary, is appropriated from the State College and University Trust Fund to the Board of Trustees of the University of Illinois for scholarship grant awards, in accordance with Public Act 91-0083.

Section 20. The sum of \$1,000,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the University of Illinois for the Complete Help and Assistance Necessary for a College Education (C.H.A.N.C.E) program at the Office of School Relations at the Chicago Campus.

Section 99. Effective date. This Act takes effect July 1, 25 2005.
