

## 94TH GENERAL ASSEMBLY State of Illinois 2005 and 2006 HB4181

Introduced 11/03/05, by Rep. Jack D. Franks - Linda Chapa LaVia

## SYNOPSIS AS INTRODUCED:

320 ILCS 55/35

Amends the Illinois Prescription Drug Discount Program Act. In provisions concerning eligibility for the program, deletes the requirement that an applicant must have household income equal to or less than 300% of the Federal Poverty Level. Effective immediately.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Prescription Drug Discount Program

  Act is amended by changing Section 35 as follows:

7 Sec. 35. Program eligibility.

(320 ILCS 55/35)

(a) Any person may apply to the Department or its program 8 administrator for participation in the program in the form and 9 manner required by the Department. The Department or its 10 program administrator shall determine the eligibility of each 11 applicant for the program within 30 days after the date of 12 application. To participate in the program an eligible Illinois 13 14 resident whose application has been approved must pay the fee 15 determined by the Director upon enrollment and annually thereafter and shall receive a program identification card. The 16 17 card may be presented to an authorized pharmacy to assist the pharmacy in verifying eligibility under the program. If the 18 19 Department is the program administrator, the Department shall 20 deposit the enrollment fees collected into the Illinois Prescription Drug Discount Program Fund. If the program 21 22 administrator is a contracted vendor, the vendor may collect the enrollment fees and must report all such collected 23 enrollment fees to the Department on a regular basis. The 24 25 enrollment fees deposited into the Illinois Prescription Drug 26 Discount Program Fund must be separately accounted for by the Department. If 2 or more persons are eligible for any benefit 27 28 under this Act and are members of the same household, each 29 participating household member shall apply and pay the fee 30 required for the purpose of obtaining an identification card. To participate in the program, an applicant must (i) be a 31 resident of Illinois and (ii) have household income equal to or 32

## less than 300% of the Federal Poverty Level.

- 2 (b) Proceeds from annual enrollment fees shall be used to
- 3 offset the administrative cost of this Act. The Department may
- 4 reduce the annual enrollment fee by rule if the revenue from
- 5 the enrollment fees is in excess of the costs to carry out the
- 6 program.
