1 AN ACT concerning regulation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Consumer Installment Loan Act is amended by changing Section 1 as follows:
- 6 (205 ILCS 670/1) (from Ch. 17, par. 5401)
- 7 Sec. 1. License required to engage in business. No person, partnership, association, limited liability company, 8 9 corporation shall engage in the the business of making loans of money in a principal amount not exceeding \$25,000, and charge, 10 11 contract for, or receive on any such loan a greater rate of interest, discount, or consideration therefor than the lender 12 would be permitted by law to charge if he were not a licensee 13 hereunder, except as authorized by this Act after first 14 15 obtaining a license from the Director of Financial Institutions
