A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much  
6 thereof as may be necessary, respectively, for the objects  
7 and purposes hereinafter named, are appropriated to the Board  
8 of the Trustees of Southern Illinois University to meet  
9 ordinary and contingent expenses for the fiscal year ending  
10 June 30, 2007:

11 Payable from the General Revenue Fund:

12	For Personal Services, including payment	
13	to the university for personal services	
14	costs incurred during the fiscal year	
15	and salaries accrued but unpaid to academic	
16	personnel for personal services rendered	
17	during the academic year 2005-2006 .....	194,941,900
18	For State Contributions to Social	
19	Security, for Medicare .....	2,315,900
20	For Group Insurance .....	3,698,300
21	For Contractual Services .....	12,566,700
22	For Travel .....	53,600
23	For Commodities .....	1,477,400
24	For Equipment .....	2,455,900
25	For Telecommunications Services .....	1,854,800
26	For Operation of Automotive Equipment .....	657,200
27	For Awards and Grants .....	<u>155,500</u>
28	Total	\$220,177,200

29 Section 10. The sum of \$200,000, or so much thereof as  
30 may be necessary, is appropriated from the General Revenue

1 Fund to the Board of Trustees of Southern Illinois University  
2 for the Special Services (TRIO) program for improvement of  
3 matriculation, retention, and completion rates of minority  
4 students at the Edwardsville and Carbondale campuses.

5 Section 15. The sum of \$250,000, or so much thereof as  
6 may be necessary, is appropriated from the General Revenue  
7 Fund to the Board of Trustees of Southern Illinois University  
8 for the Vince Demuzio Governmental Internship Program.

9 Section 20. The sum of \$1,200,000, or so much thereof  
10 as may be necessary, is appropriated from the General Revenue  
11 Fund to the Board of Trustees of Southern Illinois University  
12 for the School of Medicine Lab.

13 Section 99. Effective date. This Act takes effect July 1,  
14 2006.
