1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated from the
8 Illinois Workers' Compensation Commission Operations Fund to
9 the Illinois Workers' Compensation Commission:

13 Section 10. In addition to the amounts heretofore
14 appropriated, the following named amount, or so much thereof
15 as may be necessary, is appropriated from the Illinois
16 Workers' Compensation Commission Operations Fund to the
17 Illinois Workers' Compensation Commission for the project
18 hereinafter enumerated:

20 For rent, staffing and equipment to operate
21 an office in Peoria

22 Section 15. The amount of \$115,000, or so much thereof
23 as may be necessary, is appropriated from the Illinois
24 Workers' Compensation Commission Operations Fund to the
25 Illinois Workers' Compensation Commission for printing and
26 distribution of Workers' Compensation handbooks containing
27 information as to the rights and obligations of employers.

28 Section 20. The amount of \$244,200, or so much thereof
29 as may be necessary, is appropriated from the Illinois
30 Workers' Compensation Commission Operations Fund to the
31 Illinois Workers' Compensation Commission for the

1 implementation and operation of an accident reporting system.

2 Section 25. The sum of \$118,000, or so much thereof as
3 may be necessary, is appropriated from the Illinois Workers'
4 Compensation Commission Operations Fund to the Illinois
5 Workers' Compensation Commission for all costs associated
6 with the establishment and operation of a satellite office in
7 the Metro East area.

8 Section 30. The amount of \$800,000, or so much thereof
9 as may be necessary, is appropriated from the Illinois
10 Workers' Compensation Commission Operations Fund to Illinois
11 Workers' Compensation Commission for costs associated with
12 the establishment, administration and operations of the
13 Insurance Compliance Division of the workers' compensation
14 anti-fraud program administered by Illinois Workers'
15 Compensation Commission.

16 Section 35. The amount of \$940,000, or so much thereof
17 as may be necessary, is appropriated from the Illinois
18 Workers' Compensation Commission Operations Fund to Illinois
19 Workers' Compensation Commission for all costs associated
20 with the establishment, administration and operation of a
21 third Commission panel

22 Section 40. The amount of \$250,000, or so much thereof
23 as may be necessary, is appropriated from the Illinois
24 Workers' Compensation Commission Operations Fund to Illinois
25 Workers' Compensation Commission for costs associated with
26 the establishment of the Medical Fee Schedule and other
27 provisions of the Workers Compensation Act.

28 Section 99. Effective date. This Act takes effect July 1,
29 2006.
