23 Section 45. The sum of \$12,440,000, or so much thereof 24 as may be necessary, is appropriated from the Juvenile Accountability Incentive Block Grant Trust Fund to 25 the Illinois Criminal Justice Information Authority for awards 26 and grants to state agencies and units of local government, 27 including operational expenses of the Authority in support of 28 29 the Juvenile Accountability Incentive Block Grant program.

30 Section 99. Effective date. This Act takes effect July 1,31 2006.
