Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

5	Section 5. The following named sums, or so much thereof

19 Section 10. The sum of \$11,500,000, or so much thereof 20 as may be necessary, is appropriated from the Federal Support 21 Agreement Revolving Fund to the Department of Military 22 Affairs Facilities Division for expenses related to Army 23 National Guard Facilities operations and maintenance as 24 provided for in the Cooperative Funding Agreements, including 25 costs in prior years.

Section 15. The sum of \$337,000, or so much thereof as may be necessary, is appropriated from the Federal Support Agreement Revolving Fund to the Department of Military Affairs Facilities Division for expenses related to the Bartonville and Kankakee armories for operations and maintenance according to the Joint-Use Agreement, including -3- OMB094 00171 LLC 30171 b

2 Section 20. The sum of \$43,000, or so much thereof as 3 may be necessary, is appropriated from the General Revenue 4 Fund to the Department of Military Affairs Facilities 5 Division for rehabilitation and minor construction at 6 armories and camps.

Section 25. The sum of \$7,400, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Department of Military Affairs Office of the Adjutant General Division for expenses related to the care and preservation of historic artifacts.

Section 30. The sum of \$1,432,000, or so much thereof as may be necessary, is appropriated from the Military Affairs Trust Fund to the Department of Military Affairs Office of the Adjutant General Division to support youth and other programs, provided such amounts shall not exceed funds to be made available from public or private sources.

Section 35. The sum of \$5,000,000, or so much thereof as 18 may be necessary, is appropriated from the Illinois Military 19 Family Relief Fund to the Department of Military Affairs 20 21 Office of the Adjutant General Division for the issuance of 22 grants to persons or families of persons who are members of the Illinois National Guard or Illinois residents who are 23 members of the armed forces of the United States and who have 2.4 been called to active duty as a result of the September 11, 25 2001 terrorist attacks, including costs in prior years. 26

27 Section 40. The sum of \$567,500, or so much thereof as 28 may be necessary, is appropriated from General Revenue Fund 29 to the Department of Military Affairs Office of the Adjutant HB5761 -4- OMB094 00171 LLC 30171 b 1 General Division for costs and expenses related to or in 2 support of the public safety shared services center.

3 Section 45. No contract shall be entered into or 4 obligation incurred for any expenditures made from an 5 appropriation herein made in Section 20 until after the 6 purpose and amounts have been approved in writing by the 7 Governor.

8 Section 99. Effective date. This Act takes effect July 1,9 2006.
