1 AN ACT concerning transportation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Vehicle Code is amended by changing

 Sections 12-215 and 15-101 as follows:
- 6 (625 ILCS 5/12-215) (from Ch. 95 1/2, par. 12-215)
- Sec. 12-215. Oscillating, rotating or flashing lights on motor vehicles. Except as otherwise provided in this Code:
- 9 (a) The use of red or white oscillating, rotating or 10 flashing lights, whether lighted or unlighted, is prohibited 11 except on:
- 1. Law enforcement vehicles of State, Federal or local authorities;
 - 2. A vehicle operated by a police officer or county coroner and designated or authorized by local authorities, in writing, as a law enforcement vehicle; however, such designation or authorization must be carried in the vehicle;
 - 3. Vehicles of local fire departments and State or federal firefighting vehicles;
 - 4. Vehicles which are designed and used exclusively as ambulances or rescue vehicles; furthermore, such lights shall not be lighted except when responding to an emergency call for and while actually conveying the sick or injured;
 - 5. Tow trucks licensed in a state that requires such lights; furthermore, such lights shall not be lighted on any such tow truck while the tow truck is operating in the State of Illinois;
 - 6. Vehicles of the Illinois Emergency Management Agency, vehicles of the Illinois Department of Public Health, and vehicles of the Department of Nuclear Safety;
 - 7. Vehicles operated by a local or county emergency

management services agency as defined in the Illinois

Emergency Management Agency Act; and

- 8. School buses operating alternately flashing head lamps as permitted under Section 12-805 of this Code; and \div
- 9. 8. Vehicles that are equipped and used exclusively as organ transplant vehicles when used in combination with blue oscillating, rotating, or flashing lights; furthermore, these lights shall be lighted only when the transportation is declared an emergency by a member of the transplant team or a representative of the organ procurement organization.
- (b) The use of amber oscillating, rotating or flashing lights, whether lighted or unlighted, is prohibited except on:
 - 1. Second division vehicles designed and used for towing or hoisting vehicles; furthermore, such lights shall not be lighted except as required in this paragraph 1; such lights shall be lighted when such vehicles are actually being used at the scene of an accident or disablement; if the towing vehicle is equipped with a flat bed that supports all wheels of the vehicle being transported, the lights shall not be lighted while the vehicle is engaged in towing on a highway; if the towing vehicle is not equipped with a flat bed that supports all wheels of a vehicle being transported, the lights shall be lighted while the towing vehicle is engaged in towing on a highway during all times when the use of headlights is required under Section 12-201 of this Code;
 - 2. Motor vehicles or equipment of the State of Illinois, local authorities and contractors; furthermore, such lights shall not be lighted except while such vehicles are engaged in maintenance or construction operations within the limits of construction projects;
 - 3. Vehicles or equipment used by engineering or survey crews; furthermore, such lights shall not be lighted except while such vehicles are actually engaged in work on a highway;

4. Vehicles of public utilities, municipalities, or

other construction, maintenance or automotive service

(6.1) The front and rear of motorized equipment or vehicles that (i) are not owned by the State of Illinois or

the Department under Section 15-301 of this Code;

service or construction on a highway;

- any political subdivision of the State, (ii) are designed and used for removal of snow and ice from highways and parking lots, and (iii) are equipped with a snow plow that is 12 feet in width; these lights may not be lighted except when the motorized equipment or vehicle is actually being used for those purposes on behalf of a unit of government;
- 7. Fleet safety vehicles registered in another state, furthermore, such lights shall not be lighted except as provided for in Section 12-212 of this Code;
- 8. Such other vehicles as may be authorized by local authorities;
- 9. Law enforcement vehicles of State or local authorities when used in combination with red oscillating, rotating or flashing lights;
 - 9.5. Propane delivery trucks;
- 10. Vehicles used for collecting or delivering mail for the United States Postal Service provided that such lights shall not be lighted except when such vehicles are actually being used for such purposes;
 - 11. Any vehicle displaying a slow-moving vehicle

1	emblem as provided in Section 12-205.1;
2	12. All trucks equipped with self-compactors or
3	roll-off hoists and roll-on containers for garbage or
4	refuse hauling. Such lights shall not be lighted except
5	when such vehicles are actually being used for such
6	purposes;
7	13. Vehicles used by a security company, alarm
8	responder, or control agency;
9	14. Security vehicles of the Department of Human
10	Services; however, the lights shall not be lighted except
11	when being used for security related purposes under the
12	direction of the superintendent of the facility where the
13	vehicle is located; and
14	15. Vehicles of union representatives, except that the
15	lights shall be lighted only while the vehicle is within
16	the limits of a construction project.
17	(c) The use of blue oscillating, rotating or flashing
18	lights, whether lighted or unlighted, is prohibited except on:
19	1. Rescue squad vehicles not owned by a fire department
20	and vehicles owned or fully operated by a:
21	voluntary firefighter;
22	<pre>paid firefighter;</pre>
23	part-paid firefighter;
24	call firefighter;
25	member of the board of trustees of a fire
26	<pre>protection district;</pre>
27	paid or unpaid member of a rescue squad;
28	paid or unpaid member of a voluntary ambulance
29	unit; or
30	paid or unpaid members of a local or county
31	emergency management services agency as defined in the
32	Illinois Emergency Management Agency Act, designated
33	or authorized by local authorities, in writing, and

However, such lights are not to be lighted except when

responding to a bona fide emergency.

Any person using these lights in accordance with this subdivision (c)1 must carry on his or her person an identification card or letter identifying him or her as a member of a bona fide fire department, fire protection district, rescue squad, ambulance unit, or emergency management services agency. The card or letter must include:

- (A) the name of the fire department, fire protection district, rescue squad, ambulance unit, or emergency management services agency;
- (B) the member's position within the fire department, fire protection district, rescue squad, ambulance unit, or emergency management services agency;
 - (C) the member's term of service; and
- (D) the name of a person within the fire department, fire protection district, rescue squad, ambulance unit, or emergency management services agency to contact to verify the information provided.
- 2. Police department vehicles in cities having a population of 500,000 or more inhabitants.
- 3. Law enforcement vehicles of State or local authorities when used in combination with red oscillating, rotating or flashing lights.
- 4. Vehicles of local fire departments and State or federal firefighting vehicles when used in combination with red oscillating, rotating or flashing lights.
- 5. Vehicles which are designed and used exclusively as ambulances or rescue vehicles when used in combination with red oscillating, rotating or flashing lights; furthermore, such lights shall not be lighted except when responding to an emergency call.
- 6. Vehicles that are equipped and used exclusively as organ transport vehicles when used in combination with red oscillating, rotating, or flashing lights; furthermore,

these lights shall only be lighted when the transportation is declared an emergency by a member of the transplant team or a representative of the organ procurement organization.

- 7. Vehicles of the Illinois Emergency Management Agency, vehicles of the Illinois Department of Public Health, and vehicles of the Department of Nuclear Safety, when used in combination with red oscillating, rotating, or flashing lights.
- 8. Vehicles operated by a local or county emergency management services agency as defined in the Illinois Emergency Management Agency Act, when used in combination with red oscillating, rotating, or flashing lights.
- (c-1) In addition to the blue oscillating, rotating, or flashing lights permitted under subsection (c), and notwithstanding subsection (a), a vehicle operated by a voluntary firefighter, a voluntary member of a rescue squad, or a member of a voluntary ambulance unit may be equipped with flashing white headlights and blue grill lights, which may be used only in responding to an emergency call.
- (c-2) In addition to the blue oscillating, rotating, or flashing lights permitted under subsection (c), and notwithstanding subsection (a), a vehicle operated by a paid or unpaid member of a local or county emergency management services agency as defined in the Illinois Emergency Management Agency Act, may be equipped with white oscillating, rotating, or flashing lights to be used in combination with blue oscillating, rotating, or flashing lights, if authorization by local authorities is in writing and carried in the vehicle.
- (d) The use of a combination of amber and white oscillating, rotating or flashing lights, whether lighted or unlighted, is prohibited except motor vehicles or equipment of the State of Illinois, local authorities, contractors, and union representatives may be so equipped; furthermore, such lights shall not be lighted on vehicles of the State of Illinois, local authorities, and contractors except while such vehicles are engaged in highway maintenance or construction

- 1 operations within the limits of highway construction projects,
- 2 and shall not be lighted on the vehicles of union
- 3 representatives except when those vehicles are within the
- 4 limits of a construction project.
- 5 (e) All oscillating, rotating or flashing lights referred
- 6 to in this Section shall be of sufficient intensity, when
- 7 illuminated, to be visible at 500 feet in normal sunlight.
- 8 (f) Nothing in this Section shall prohibit a manufacturer
- 9 of oscillating, rotating or flashing lights or his
- 10 representative from temporarily mounting such lights on a
- 11 vehicle for demonstration purposes only.
- 12 (g) Any person violating the provisions of subsections (a),
- 13 (b), (c) or (d) of this Section who without lawful authority
- 14 stops or detains or attempts to stop or detain another person
- shall be guilty of a Class 4 felony.
- 16 (h) Except as provided in subsection (g) above, any person
- 17 violating the provisions of subsections (a) or (c) of this
- 18 Section shall be quilty of a Class A misdemeanor.

- Sec. 15-101. Scope and effect of Chapter 15.
- 26 (a) It is unlawful for any person to drive or move on, upon
- or across or for the owner to cause or knowingly permit to be
- driven or moved on, upon or across any highway any vehicle or
- vehicles of a size and weight exceeding the limitations stated
- 30 in this Chapter or otherwise in violation of this Chapter, and
- 31 the maximum size and weight of vehicles herein specified shall
- 32 be lawful throughout this State, and local authorities shall
- 33 have no power or authority to alter such limitations except as
- express authority may be granted in this Chapter.
- 35 (b) The provisions of this Chapter governing size, weight

and load do not apply to fire apparatus or equipment for snow and ice removal operations owned or operated by any governmental body, or to implements of husbandry, as defined in Chapter 1 of this Code, temporarily operated or towed in a combination upon a highway provided such combination does not consist of more than 3 vehicles or, in the case of hauling fresh, perishable fruits or vegetables from farm to the point of first processing, not more than 3 wagons being towed by an implement of husbandry, or to a vehicle operated under the terms of a special permit issued hereunder.

(c) The provisions of this Chapter governing size, weight, and load do not apply to any snow and ice removal equipment that is no more than 12 feet in width, if the equipment displays flags at least 18 inches square mounted on the driver's side of the snow plow.

These vehicles must be equipped with an illuminated rotating, oscillating, or flashing amber light or lights, or a flashing amber strobe light or lights, mounted on the top of the cab and of sufficient intensity to be visible at 500 feet in normal sunlight. If the load on the transport vehicle blocks the visibility of the amber lighting from the rear of the vehicle, the vehicle must also be equipped with an illuminated rotating, oscillating, or flashing amber light or lights, or a flashing amber strobe light or lights, mounted on the rear of the load and of sufficient intensity to be visible at 500 feet in normal sunlight.
