AN ACT concerning local government.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Illinois Municipal Code is amended by 5 changing Section 11-20-8 as follows:

6 (65 ILCS 5/11-20-8) (from Ch. 24, par. 11-20-8)

Sec. 11-20-8. Pest extermination; liens. The corporate 7 each municipality may provide 8 authorities of for the extermination of pests rats in the municipality, and charge to 9 and collect from the owners of and persons interested in 10 private property the reasonable cost and expense of preventing 11 ingress of pests rats to their property and of pest rat 12 extermination therein, after notice to such owners or persons 13 14 as provided by ordinance and failures of such owners or persons 15 to comply. This cost and expense is a lien upon the real estate all other 16 affected, superior to existing liens and 17 encumbrances, except tax liens if within 60 days after such cost and expense is incurred the municipality, or person 18 19 performing the service by authority of the municipality, in his 20 or its own name, files notice of lien in the office of the recorder in the county in which the real estate is located or 21 in the office of the Registrar of Titles of such county if the 22 real estate affected is registered under "An Act concerning 23 land titles", approved May 1, 1897, as amended. The notice 24 25 shall consist of a sworn statement setting out (1)a 26 description of the real estate sufficient for identification thereof, (2) the amount of money representing the cost and 27 28 expense incurred or payable for the service, and (3) the date 29 or dates when such cost and expense was incurred by the 30 municipality. However, the lien of such municipality shall not be valid as to any purchaser, mortgagee, judgment creditor, or 31 32 other lienor whose rights in and to the real estate arise SB0169 Engrossed

1 subsequent to the pest rat extermination and prior to the 2 filing of the notice of such lien in the office of the 3 recorder, or in the office of the Registrar of Titles, as 4 aforesaid. Upon payment of the cost and expense by the owner of 5 or persons interested in the property after notice of lien has been filed, the lien shall be released by the municipality or 6 7 person in whose name the lien has been filed and the release 8 may be filed of record as in the case of filing notice of lien. The lien may be enforced by proceedings to foreclose as in case 9 of mortgages or mechanics' liens. Actions to foreclose this 10 lien shall be commenced within one year after the date of 11 12 filing notice of lien.

13 "Pests", as used in this Section 11-20-8, means undesirable arthropods (including certain insects, spiders, mites, ticks, 14 and related organisms), wood infesting organisms, rats, mice, 15 16 and other obnoxious undesirable animals, but does not include a 17 feral cat, a "companion animal" as that term is defined in the Humane Care for Animals Act (510 ILCS 70/), "animals" as that 18 term is defined in the Illinois Diseased Animals Act (510 ILCS 19 20 50/), or animals protected by the Wildlife Code (520 ILCS 5/).
