

1 AN ACT concerning local government.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Metropolitan Water Reclamation District Act
5 is amended by adding Section 300 as follows:

6 (70 ILCS 2605/300 new)

7 Sec. 300. District enlarged. Upon the effective date of
8 this amendatory Act of the 94th General Assembly, the corporate
9 limits of the Metropolitan Water Reclamation District are
10 extended to include within those limits the following described
11 tracts of land and those tracts are annexed to the District.

33 Section 90. The State Mandates Act is amended by adding

1 Section 8.29 as follows:

2 (30 ILCS 805/8.29 new)

3 Sec. 8.29. Exempt mandate. Notwithstanding Sections 6 and 8
4 of this Act, no reimbursement by the State is required for the
5 implementation of any mandate created by this amendatory Act of
6 the 94th General Assembly.

7 Section 99. Effective date. This Act takes effect upon
8 becoming law.
