- Section 2. The Assisted Living and Shared Housing Act is amended by changing Section 76 as follows:

- 7 Sec. 76. Vaccinations.
  - (a) Before a prospective resident's admission to an assisted living establishment or shared housing establishment that does not provide medication administration as an optional service, the establishment shall advise the prospective resident to consult a physician to determine whether the prospective resident should obtain a vaccination against pneumococcal pneumonia or influenza, or both.
- 15 (b) An assisted living establishment or shared housing establishment that provides medication administration as an 16 17 optional service shall annually administer or arrange for administration of a vaccination against influenza to each 18 19 in accordance with the recommendations of Advisory Committee on Immunization Practices of the Centers for 20 Disease Control and Prevention that are most recent to the time 21 of vaccination, unless the vaccination is 22 medically contraindicated or the resident has refused the vaccine. 23 Influenza vaccinations for all residents age 65 or over shall 24 25 be completed by November 30 of each year or as soon as 26 practicable if vaccine supplies are not available before November 1. Residents admitted after November 30, during the 27 28 flu season, and until February 1 shall, as 29 appropriate, receive an influenza vaccination prior to or upon 30 admission or as soon as practicable if vaccine supplies are not available at the time of the admission, unless the vaccine is 31 32 medically contraindicated or the resident has refused the

vaccine. In the event that the Advisory Committee on Immunization Practices of the Centers for Disease Control and Prevention determines that dates of administration other than those stated in this Section are optimal to protect the health of residents, the Department is authorized to adopt rules to require vaccinations at those times rather than the times stated in this Section. An establishment shall document in the resident's medication record that an annual vaccination against influenza was administered, <a href="mailto:arranged">arranged</a>, refused, or medically contraindicated.

An assisted living establishment or shared housing establishment that provides medication administration as an shall optional service administer for or arrange administration of a pneumococcal vaccination to each resident who is age 65 or over, in accordance with the recommendations of the Advisory Committee on Immunization Practices of the Centers for Disease Control and Prevention, who has not received this immunization prior to or upon admission to the establishment, unless the resident refuses the offer for vaccination or the vaccination is medically contraindicated. An establishment shall document in each resident's medication record that a vaccination against pneumococcal pneumonia was offered and administered, <u>arranged</u>, refused, or medically contraindicated.

vaccination, of unless the vaccination is medically contraindicated or the resident has refused the vaccine. Influenza vaccinations for all residents age 65 and over shall be completed by November 30 of each year or as soon as practicable if vaccine supplies are not available before November 1. Residents admitted after November 30, during the flu season, and until February 1 shall, as medically appropriate, receive an influenza vaccination prior to or upon admission or as soon as practicable if vaccine supplies are not available at the time of the admission, unless the vaccine is medically contraindicated or the resident has refused the vaccine. In the event that the Advisory Committee Immunization Practices of the Centers for Disease Control and Prevention determines that dates of administration other than those stated in this Act are optimal to protect the health of residents, the Department is authorized to develop rules to mandate vaccinations at those times rather than the times stated in this Act. A facility shall document in the resident's medical record that an annual vaccination against influenza was administered, arranged, refused or medically contraindicated.

(b) A facility shall <u>administer</u> provide or arrange for administration of a pneumococcal vaccination to each resident who is age 65 and over, in accordance with the recommendations of the Advisory Committee on Immunization Practices of the Centers for Disease Control and Prevention, who has not received this immunization prior to or upon admission to the facility, unless the resident refuses the offer for vaccination or the vaccination is medically contraindicated. A facility shall document in each resident's medical record that a vaccination against pneumococcal pneumonia was offered and administered, <u>arranged</u>, refused, or medically contraindicated.

(a) A home health agency shall annually administer or 3 arrange for administration of a vaccination against influenza 4 5 to each client, in accordance with the recommendations of the Advisory Committee on Immunization Practices of the Centers for 6 Disease Control and Prevention that are most recent to the time 7 of vaccination, unless the vaccination is medically 8 9 contraindicated or the client has refused the vaccine. Influenza vaccinations for all clients age 65 or over shall be 10 11 completed by November 30 of each year or as soon as practicable 12 if vaccine supplies are not available before November 1. Home health clients whose services start after November 30, during 13 the flu season, and until February 1 shall, as medically 14 appropriate, receive an influenza vaccination prior to or upon 15 16 service initiation or as soon as practicable if vaccine 17 supplies are not available at the time of the service initiation, unless the vaccine is medically contraindicated or 18 the client has refused the vaccine. If the Advisory Committee 19 20 on Immunization Practices of the Centers for Disease Control and Prevention determines that dates of administration other 21 than those stated in this Section are optimal to protect the 22 health of clients, the Department may adopt rules to mandate 23 vaccinations at those times rather than the times stated in 24 this Section. A home health agency shall document in the 25 client's medical record that an annual vaccination against 26 27 influenza was administered, arranged, refused, or medically 28 contraindicated. (b) A home health agency shall administer or arrange for 29 30 administration of a pneumococcal vaccination, in accordance 31 with the recommendations of the Advisory Committee on Immunization Practices of the Centers for Disease Control and 32 Prevention, to each client who is age 65 or over and who has 33 not received this immunization prior to or upon service 34 35 initiation, unless the client refuses the offer for vaccination

or the vaccination is medically contraindicated. A home health
