23 Section 15. The sum of \$960,000, or so much thereof as 24 may be necessary, is appropriated from the General Revenue 25 Fund to the Illinois Arts Council for the purpose of funding 26 administrative and grant expenses associated with humanities 27 programs and related activities.

28 Section 20. The amount of \$364,800, or so much thereof 29 as may be necessary, is appropriated from the General Revenue 30 Fund to the Illinois Arts Council for grants to certain 31 public radio and television stations for operating costs. SB1362 -3- OMB094 00003 JAP 30003 b

1 Section 25. The amount of \$4,708,000, or so much thereof 2 as may be necessary is appropriated from the General Revenue 3 Fund to the Illinois Arts Council for grants to certain 4 public radio and television stations and related 5 administrative expenses, pursuant to the Public Radio and 6 Television Grant Act.

7 Section 99. Effective date. This Act takes effect July 1,8 2005.
