SYNOPSIS AS INTRODUCED:

5 ILCS 420/4A-102	from Ch. 127, par. 604A-102
5 ILCS 420/4A-103	from Ch. 127, par. 604A-103

Amends the Illinois Governmental Ethics Act. For persons filing statements of economic interests with the Secretary of State, requires the disclosure of entities (now, entities doing business with the State) from or in which the person derived certain income or had certain ownership interests.

AN ACT concerning government.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Illinois Governmental Ethics Act is amended
by changing Sections 4A-102 and 4A-103 as follows:

6 (5 ILCS 420/4A-102) (from Ch. 127, par. 604A-102)

Sec. 4A-102. The statement of economic interests required 7 by this Article shall include the economic interests of the 8 person making the statement as provided in this Section. The 9 interest (if constructively controlled by the person making the 10 statement) of a spouse or any other party, shall be considered 11 to be the same as the interest of the person making the 12 statement. Campaign receipts shall not be included in this 13 14 statement.

(a) The following interests shall be listed by all personsrequired to file:

(1) The name, address and type of practice of any 17 18 professional organization or individual professional 19 practice in which the person making the statement was an officer, director, associate, partner or proprietor, or 20 served in any advisory capacity, from which income in 21 excess of \$1200 was derived during the preceding calendar 22 23 year;

(2) The nature of professional services (other than
services rendered to the unit or units of government in
relation to which the person is required to file) and the
nature of the entity to which they were rendered if fees
exceeding \$5,000 were received during the preceding
calendar year from the entity for professional services
rendered by the person making the statement.

1 a capital gain of \$5,000 or more was realized in the 2 preceding calendar year.

3 (4) The name of any unit of government which has 4 employed the person making the statement during the 5 preceding calendar year other than the unit or units of 6 government in relation to which the person is required to 7 file.

8 (5) The name of any entity from which a gift or gifts, 9 or honorarium or honoraria, valued singly or in the 10 aggregate in excess of \$500, was received during the 11 preceding calendar year.

(b) The following interests shall also be listed by persons
listed in items (a) through (f) and item (l) of Section 4A-101:

(1) The name and instrument of ownership in any entity 14 doing business in the State of Illinois, in which an 15 16 ownership interest held by the person at the date of filing is in excess of \$5,000 fair market value or from which 17 dividends of in excess of \$1,200 were derived during the 18 preceding calendar year. (In the case of real estate, 19 20 location thereof shall be listed by street address, or if none, then by legal description). No time or demand deposit 21 in a financial institution, nor any debt instrument need be 22 listed; 23

(2) Except for professional service entities, the name
of any entity and any position held therein from which
income of in excess of \$1,200 was derived during the
preceding calendar year, if the entity does business in the
State of Illinois. No time or demand deposit in a financial
institution, nor any debt instrument need be listed.

30 (3) The identity of any compensated lobbyist with whom 31 the person making the statement maintains a close economic 32 association, including the name of the lobbyist and 33 specifying the legislative matter or matters which are the 34 object of the lobbying activity, and describing the general 35 type of economic activity of the client or principal on 36 whose behalf that person is lobbying. 1 2 (c) The following interests shall also be listed by persons listed in items (g), (h), and (i) of Section 4A-101:

3 (1) The name and instrument of ownership in any entity doing business with a unit of local government in relation 4 5 to which the person is required to file if the ownership 6 interest of the person filing is greater than \$5,000 fair market value as of the date of filing or if dividends in 7 excess of \$1,200 were received from the entity during the 8 9 preceding calendar year. (In the case of real estate, 10 location thereof shall be listed by street address, or if 11 none, then by legal description). No time or demand deposit in a financial institution, nor any debt instrument need be 12 listed. 13

14 (2) Except for professional service entities, the name
15 of any entity and any position held therein from which
16 income in excess of \$1,200 was derived during the preceding
17 calendar year if the entity does business with a unit of
18 local government in relation to which the person is
19 required to file. No time or demand deposit in a financial

The name of any entity and the nature of the 21 (3) governmental action requested by any entity which has 22 applied to a unit of local government in relation to which 23 the person must file for any license, franchise or permit 24 25 for annexation, zoning or rezoning of real estate during the preceding calendar year if the ownership interest of 26 27 the person filing is in excess of \$5,000 fair market value 28 at the time of filing or if income or dividends in excess of \$1,200 were received by the person filing from the 29 30 entity during the preceding calendar year.
