19 Section 15. The amount of \$150,000, or as much of that  
20 amount as may be necessary, is appropriated to the State  
21 Board of Elections from the Voters' Guide Fund for the  
22 operations of that Fund.

23 Section 99. Effective date. This Act takes effect July 1,  
24 2006.
