13 on page 134, by replacing lines 1 through 3 with the following:

2 on page 134, immediately below line 14, by inserting the

4 "(a-5) Income eligibility limitation. For purposes of this  
5 Section, "income eligibility limitation" means an amount:

6 (i) for grant years before the 1998 grant year, less  
7 than \$14,000;

8 (ii) for the 1998 and 1999 grant year, less than  
9 \$16,000;

10 (iii) for grant years 2000 through 2007:

11 (A) less than \$21,218 for a household containing  
12 one person;

13 (B) less than \$28,480 for a household containing 2  
14 persons; or

15 (C) less than \$35,740 for a household containing 3  
16 or more persons; or

17 (iv) for grant years 2008 and thereafter:

18 (A) less than \$22,218 for a household containing  
19 one person;

20 (B) less than \$29,480 for a household containing 2  
21 persons; or

22 (C) less than \$36,740 for a household containing 3  
23 or more persons."; and

24 on page 137, by replacing lines 7 through 13 with the

2 "have a maximum household income of less than the income  
3 eligibility limitation, as defined in subsection (a-5) \$14,000  
4 for grant years before the 1998 grant year, less than \$16,000  
5 for the 1998 and 1999 grant years, and less than (i) \$21,218  
6 for a household containing one person, (ii) \$28,480 for a  
7 household containing 2 persons, or (iii) \$35,740 for a  
8 household containing 3 more persons for the 2000 grant year and  
9 thereafter. In addition, each eligible person must (1) obtain".
