The moneys may not be used for institutional, organizational, or community-based overhead costs, indirect costs, or levies.

8 <u>Moneys received for the purposes of this Section,</u> 9 <u>including, without limitation, net revenue from the special</u> 10 <u>instant scratch-off game and gifts, grants, and awards from any</u> 11 <u>public or private entity, must be deposited into the Fund.
