1 AN ACT concerning guardianship.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 10. The Probate Act of 1975 is amended by changing
- 5 Sections 11-5.4 and 11-13.2 as follows:
- 6 (755 ILCS 5/11-5.4)
- 7 Sec. 11-5.4. Short-term guardian.
- 8 (a) A parent, adoptive parent, or adjudicated parent whose 9 parental rights have not been terminated, or the guardian of the person of a minor may appoint in writing, without court 10 approval, a short-term guardian of an unmarried minor or a 11 child likely to be born. The written instrument appointing a 12 short-term quardian shall be dated and shall identify the 13 14 appointing parent or quardian, the minor, and the person appointed to be the short-term quardian. The written instrument 15 16 shall be signed by, or at the direction of, the appointing 17 parent in the presence of at least 2 credible witnesses at least 18 years of age, neither of whom is the person appointed 18 19 as the short-term quardian. The person appointed as the 20 short-term quardian shall also sign the written instrument, but 21 need not sign at the same time as the appointing parent.
- 22 (b) A parent or guardian shall not appoint a short-term 23 guardian of a minor if the minor has another living parent,

adoptive parent or adjudicated parent, whose parental rights have not been terminated, whose whereabouts are known, and who is willing and able to make and carry out day-to-day child care decisions concerning the minor, unless the nonappointing parent consents to the appointment by signing the written instrument of appointment.

- (c) The appointment of the short-term guardian is effective immediately upon the date the written instrument is executed, unless the written instrument provides for the appointment to become effective upon a later specified date or event. The short-term quardian shall have authority to act as quardian of the minor as provided in Section 11-13.2 for a period of 365 $\frac{60}{100}$ days from the date the appointment is effective, unless the written instrument provides for the appointment to terminate upon an earlier specified date or event. Only one written instrument appointing a short-term guardian may be in force at any given time.
- (d) Every appointment of a short-term guardian may be amended or revoked by the appointing parent or by the appointing quardian of the person of the minor at any time and in any manner communicated to the short-term guardian or to any other person. Any person other than the short-term quardian to whom a revocation or amendment is communicated or delivered shall make all reasonable efforts to inform the short-term quardian of that fact as promptly as possible.
 - (e) The appointment of a short-term quardian or successor

- 1 short-term guardian does not affect the rights of the other
- 2 parent in the minor.

- 3 (f) The written instrument appointing a short-term
- 4 guardian may, but need not, be in the following form:

A separate form should be completed for each child. The person appointed as the guardian must sign the form, but need not do so at the same time as the parent or parents or guardian.

This form may not be used to appoint a guardian if there is a guardian already appointed for the child, except that if a guardian of the person of the child has been appointed, that guardian may use this form to appoint a short-term guardian. Both living parents of a child may together appoint a guardian of the child, or the guardian of the person of the child may appoint a guardian of the child, for a period of up to $365 \ 60$ days through the use of this form. - 4 Sec. 11-13.2. Duties of short-term quardian of a minor.
- 5 (a) Immediately upon the effective date of the appointment of a short-term guardian, the short-term guardian shall assume 6 7 all duties as short-term quardian of the minor as provided in 8 this Section. The short-term quardian of the person shall have 9 authority to act as short-term quardian, without direction of 10 court, for the duration of the appointment, which in no case 11 shall exceed a period of $365 \frac{60}{60}$ days. The authority of the 12 short-term quardian may be limited or terminated by a court of
 - (b) Unless further specifically limited by the instrument appointing the short-term quardian, a short-term quardian shall have the authority to act as a quardian of the person of a minor as prescribed in Section 11-13, but shall not have any authority to act as guardian of the estate of a minor, except that a short-term quardian shall have the authority to apply for and receive on behalf of the minor benefits to which the child may be entitled from or under federal, State, or local organizations or programs.
