The surplus, if any, in the Road Fund 13 after the payment of principal and interest on that bonded 14 indebtedness then annually due shall be used as follows:

15 first -- to pay the cost of administration of Chapters 16 2 through 10 of the Illinois Vehicle Code, except the cost 17 of administration of Articles I and II of Chapter 3 of that 18 Code; and

19 secondly -- for expenses of the Department of 20 for construction, Transportation reconstruction, 21 improvement, repair, maintenance, operation, and 22 of highways in accordance administration with the provisions of laws relating thereto, or for any purpose 23

related or incident to and connected therewith, including 1 2 the separation of grades of those highways with railroads 3 and with highways and including the payment of awards made by the Illinois Workers' Compensation Commission under the 4 terms of the Workers' Compensation Act or 5 Workers' Occupational Diseases Act for injury or 6 death of an 7 employee of the Division of Highways in the Department of 8 Transportation; or for the acquisition of land and the 9 erection of buildings for highway purposes, including the 10 acquisition of highway right-of-way or for investigations 11 to determine the reasonably anticipated future highway 12 needs; or for making of surveys, plans, specifications and estimates for and in the construction and maintenance of 13 14 flight strips and of highways necessary to provide access 15 to military and naval reservations, to defense industries 16 and defense-industry sites, and to the sources of raw materials and for replacing existing highways and highway 17 connections shut off from general public use at military 18 19 and naval reservations and defense-industry sites, or for 20 the purchase of right-of-way, except that the State shall 21 be reimbursed in full for any expense incurred in building 22 the flight strips; or for the operating and maintaining of 23 highway garages; or for patrolling and policing the public 24 highways and conserving the peace; or for the operating 25 expenses of the Department relating to the administration 26 of public transportation programs; or for any of those

purposes or any other purpose that may be provided by law. Appropriations for any of those purposes are payable from the Road Fund. Appropriations may also be made from the Road Fund for the administrative expenses of any State agency that are related to motor vehicles or arise from the use of motor vehicles.

Beginning with fiscal year 1980 and thereafter, no Road Fund monies shall be appropriated to the following Departments or agencies of State government for administration, grants, or operations; but this limitation is not a restriction upon appropriating for those purposes any Road Fund monies that are eligible for federal reimbursement;

2. Department of Transportation, only with respect to Intercity Rail Subsidies and Rail Freight Services.

5 Beginning with fiscal year 1982 and thereafter, no Road Fund monies shall be appropriated to the following Departments 6 7 or agencies of State government for administration, grants, or operations; but this limitation is not a restriction upon 8 9 appropriating for those purposes any Road Fund monies that are 10 eligible for federal reimbursement: Department of Central 11 Management Services, except for awards made by the Illinois 12 Workers' Compensation Commission under the terms of the 13 Workers' Compensation Act or Workers' Occupational Diseases Act for injury or death of an employee of the Division of 14 15 Highways in the Department of Transportation.

Beginning with fiscal year 1984 and thereafter, no Road Fund monies shall be appropriated to the following Departments or agencies of State government for administration, grants, or operations; but this limitation is not a restriction upon appropriating for those purposes any Road Fund monies that are eligible for federal reimbursement:

of State government for administration, grants, or operations 1 2 except as provided hereafter; but this limitation is not a 3 restriction upon appropriating for those purposes any Road Fund monies that are eligible for federal reimbursement. It shall 4 5 not be lawful to circumvent the above appropriation limitations 6 bv governmental reorganization or other methods. 7 Appropriations shall be made from the Road Fund only in 8 accordance with the provisions of this Section.

9 Money in the Road Fund shall, if and when the State of Illinois incurs any bonded indebtedness for the construction of 10 11 permanent highways, be set aside and used for the purpose of 12 paying and discharging during each fiscal year the principal 13 and interest on that bonded indebtedness as it becomes due and 14 payable as provided in the Transportation Bond Act, and for no other purpose. The surplus, if any, in the Road Fund after the 15 16 payment of principal and interest on that bonded indebtedness 17 then annually due shall be used as follows:

thereunder, administrative costs of the Department of 1 2 Transportation, including, but not limited to, the 3 operating expenses of the Department relating to the administration of public transportation programs, payment 4 5 of debts and liabilities incurred in construction and reconstruction of public highways and bridges, acquisition 6 7 rights-of-way for and the cost of construction, of 8 reconstruction, maintenance, repair, and operation of 9 public highways and bridges under the direction and 10 supervision of the State, political subdivision, or 11 municipality collecting those monies, and the costs for 12 patrolling and policing the public highways (by State, 13 political subdivision, or municipality collecting that money) for enforcement of traffic laws. The separation of 14 15 grades of such highways with railroads and costs associated 16 with protection of at-grade highway and railroad crossing 17 shall also be permissible.

Appropriations for any of such purposes are payable from the Road Fund or the Grade Crossing Protection Fund as provided in Section 8 of the Motor Fuel Tax Law.

Except as provided in this paragraph, beginning with fiscal year 1991 and thereafter, no Road Fund monies shall be appropriated to the Department of State Police for the purposes of this Section in excess of its total fiscal year 1990 Road Fund appropriations for those purposes unless otherwise provided in Section 5g of this Act. 1 2004, 2005, 2006, and 2007 only, no Road Fund monies shall be 2 appropriated to the Department of State Police for the purposes 3 of this Section in excess of \$97,310,000. It shall not be 4 lawful to circumvent this limitation on appropriations by 5 governmental reorganization or other methods unless otherwise 6 provided in Section 5g of this Act.

In fiscal year 1994, no Road Fund monies shall be appropriated to the Secretary of State for the purposes of this Section in excess of the total fiscal year 1991 Road Fund appropriations to the Secretary of State for those purposes, plus \$9,800,000. It shall not be lawful to circumvent this limitation on appropriations by governmental reorganization or other method.

Beginning with fiscal year 1995 and thereafter, no Road Fund monies shall be appropriated to the Secretary of State for the purposes of this Section in excess of the total fiscal year 17 1994 Road Fund appropriations to the Secretary of State for those purposes. It shall not be lawful to circumvent this limitation on appropriations by governmental reorganization or other methods.

Beginning with fiscal year 2000, total Road Fund appropriations to the Secretary of State for the purposes of this Section shall not exceed the amounts specified for the following fiscal years:

9 It shall not be lawful to circumvent this limitation on 10 appropriations by governmental reorganization or other 11 methods.

No new program may be initiated in fiscal year 1991 and thereafter that is not consistent with the limitations imposed by this Section for fiscal year 1984 and thereafter, insofar as appropriation of Road Fund monies is concerned.

Nothing in this Section prohibits transfers from the Road Fund to the State Construction Account Fund under Section 5e of this Act; nor to the General Revenue Fund, as authorized by this amendatory Act of the 93rd General Assembly.

The additional amounts authorized for expenditure in this Section by Public Acts 92-0600, 93-0025, 93-0839, and 94-91 shall be repaid to the Road Fund from the General Revenue Fund in the next succeeding fiscal year that the General Revenue Fund has a positive budgetary balance, as determined by generally accepted accounting principles applicable to government. Except as otherwise provided in this Section and 1 (a) 2 Section 8n of this Act, and (c), (d), or (c), notwithstanding any other State law to the contrary, the Governor may, through 3 June 30, 2007, from time to time direct the State Treasurer and 4 5 Comptroller to transfer a specified sum from any fund held by 6 the State Treasurer to the General Revenue Fund in order to 7 help defray the State's operating costs for the fiscal year. 8 The total transfer under this Section from any fund in any 9 fiscal year shall not exceed the lesser of (i) 8% of the 10 revenues to be deposited into the fund during that fiscal year 11 or (ii) an amount that leaves a remaining fund balance of 25% 12 of the July 1 fund balance of that fiscal year. In fiscal year 13 2005 only, prior to calculating the July 1, 2004 final 14 balances, the Governor may calculate and direct the State 15 Treasurer with the Comptroller to transfer additional amounts 16 determined by applying the formula authorized in Public Act 17 93-839 to the funds balances on July 1, 2003.
