A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated to meet the
8 ordinary and contingent expenses of the Illinois Criminal
9 Justice Information Authority:

17 Section 15. The sum of \$37,000,000, or so much thereof
18 as may be necessary, is appropriated from the Criminal
19 Justice Trust Fund to the Illinois Criminal Justice
20 Information Authority for awards and grants to local units of
21 government and non-profit organizations.

22 Section 20. The sum of \$12,000,000, or so much thereof

1 as may be necessary, is appropriated from the Criminal
 2 Justice Trust Fund to the Illinois Criminal Justice
 3 Information Authority for awards and grants to state
 4 agencies.

5 Section 25. The following named sums, or so much thereof
 6 as may be necessary, are appropriated to the Illinois
 7 Criminal Justice Information Authority for activities
 8 undertaken in support of federal assistance programs
 9 administered by units of state and local government and non-
 10 profit organizations:

15 Section 30. The following named amounts, or so much
 16 thereof as may be necessary, are appropriated to the Illinois
 17 Criminal Justice Information Authority for awards and grants
 18 and other monies received from federal agencies, from other
 19 units of government, and from private/not-for-profit
 20 organizations for activities undertaken in support of
 21 investigating issues in criminal justice and for undertaking
 22 other criminal justice information projects:

5 Section 35. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects

8 Illinois Criminal Justice Information Authority for awards,
9 grants and operational support to implement the Motor Vehicle
10 Theft Prevention Act:

1 Section 40. The sum of \$40,000,000, or so much thereof
2 as may be necessary, is appropriated from the Criminal
3 Justice Trust Fund to the Illinois Criminal Justice
4 Information Authority for awards and grants to state agencies
5 and units of local government, to include operational
6 activities and programs undertaken by the Authority, in
7 support of Federal Crime Bill Initiatives.

8 Section 45. The sum of \$4,500,000, or so much thereof as
9 may be necessary, is appropriated from the Juvenile
10 Accountability Incentive Block Grant Trust Fund to the
11 Illinois Criminal Justice Information Authority for awards
12 and grants to state agencies and units of local government,
13 including operational expenses of the Authority in support of
14 the Juvenile Accountability Incentive Block Grant program.

15 Section 99. Effective date. This Act takes effect July 1,
16 2007.
