2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Metropolitan Water Reclamation District Act
is amended by adding Section 302 as follows:

6 (70 ILCS 2605/302 new)

Sec. 302. District enlarged. Upon the effective date of this amendatory Act of the 95th General Assembly, the corporate limits of the Metropolitan Water Reclamation District are extended to include within those limits the following described tract of land and the tract is annexed to the District.

12THAT PART OF THE NORTHEAST 1/4 OF SECTION 32 AND OF THE13NORTHWEST 1/4 OF SECTION 33, TOWNSHIP 42 NORTH, RANGE 914EAST OF THE THIRD PRINCIPAL MERIDIAN, BOUNDED AND DESCRIBED15AS FOLLOWS:

16COMMENCING AT THE NORTHEAST CORNER OF SECTION 32: THENCE17SOUTH ALONG THE WEST LINE OF SECTION 33, FOR A DISTANCE OF18111.37 FEET TO A POINT IN THE EASTERLY LINE OF THE ELGIN,19JOLIET AND EASTERN RAILWAY RIGHT OF WAY, FOR A PLACE OF20BEGINNING; THENCE SOUTH ALONG THE WEST LINE OF SECTION 3321FOR A DISTANCE OF 1,208.29 FEET TO THE NORTH LINE OF THE

11	NORTHERLY ALONG SAID EAST LINE OF THE RAILWAY RIGHT OF WAY,
