## SYNOPSIS AS INTRODUCED:

5 ILCS 375/6.11 55 ILCS 5/5-1069.3 65 ILCS 5/10-4-2.3 105 ILCS 5/10-22.3f

Amends the State Employees Group Insurance Act of 1971, the Counties Code, the Illinois Municipal Code, and the School Code to require coverage for medically necessary preventative physical therapy for insureds diagnosed with multiple sclerosis.

## Be it enacted by the People of the State of Illinois,

- 4 Section 5. The State Employees Group Insurance Act of 1971
- is amended by changing Section 6.11 as follows:

- 7 Sec. 6.11. Required health benefits; Illinois Insurance
- 8 Code requirements. The program of health benefits shall provide
- 9 the post-mastectomy care benefits required to be covered by a
- 10 policy of accident and health insurance under Section 356t of
- 11 the Illinois Insurance Code. The program of health benefits
- 12 shall provide the coverage required under Sections 356g.5,
- 356u, 356w, 356x, 356z.2, 356z.4, 356z.6, 356z.8, and 356z.9,
- and 356z.10 <del>356z.9</del> of the Illinois Insurance Code. The program
- of health benefits must comply with Section 155.37 of the
- 16 Illinois Insurance Code.

- 19 Section 10. The Counties Code is amended by changing
- 20 Section 5-1069.3 as follows:

- Sec. 5-1069.3. Required health benefits. If a county, 1 including a home rule county, is a self-insurer for purposes of 2 3 providing health insurance coverage for its employees, the coverage shall include coverage for the post-mastectomy care 4 5 benefits required to be covered by a policy of accident and 6 health insurance under Section 356t and the coverage required 7 under Sections 356g.5, 356u, 356w, 356x, 356z.6, <u>356z.8</u>, and 356z.9, and 356z.10  $\frac{356z.9}{}$  of the Illinois Insurance Code. The 8 9 requirement that health benefits be covered as provided in this 10 Section is an exclusive power and function of the State and is 11 a denial and limitation under Article VII, Section 6, 12 subsection (h) of the Illinois Constitution. A home rule county to which this Section applies must comply with every provision 13 of this Section. 14

- Section 15. The Illinois Municipal Code is amended by changing Section 10-4-2.3 as follows:

- Sec. 10-4-2.3. Required health benefits. If a municipality, including a home rule municipality, is a self-insurer for purposes of providing health insurance coverage for its employees, the coverage shall include coverage for the post-mastectomy care benefits required to be covered by

- 1 a policy of accident and health insurance under Section 356t
- and the coverage required under Sections 356g.5, 356u, 356w,
- 3 356x, 356z.6, 356z.8, and 356z.9, and 356z.10 356z.9 of the
- 4 Illinois Insurance Code. The requirement that health benefits
- 5 be covered as provided in this is an exclusive power and
- 6 function of the State and is a denial and limitation under
- 7 Article VII, Section 6, subsection (h) of the Illinois
- 8 Constitution. A home rule municipality to which this Section
- 9 applies must comply with every provision of this Section.

- 13 10-22.3f as follows:

- 15 Sec. 10-22.3f. Required health benefits. Insurance
- 16 protection and benefits for employees shall provide the
- 17 post-mastectomy care benefits required to be covered by a
- 18 policy of accident and health insurance under Section 356t and
- 19 the coverage required under Sections 356g.5, 356u, 356w, 356x,
- 356z.6, 356z.8, and 356z.9 of the Illinois Insurance Code.
