Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Counties Code is amended by adding Section 42000 as follows:

A county may own and operate a wind generation turbine farm, either individually or jointly with 8 9 another unit of local government, school district, or community college district that is authorized to own and operate a wind 10 generation turbine farm, that directly or indirectly reduces 11 12 the energy or other operating costs of the county. The county may ask for the assistance of any State agency, including 13 14 without limitation the Department of Commerce and Economic Opportunity, the Illinois Power Agency, or the Environmental 15 16 Protection Agency, in obtaining financing options for a wind 17 generation turbine farm.
- Section 10. The Illinois Municipal Code is amended by adding Section 11-15.3-1 as follows:

- 21 <u>Sec. 11-15.3-1. Wind farms. A municipality may own and</u>

operate a wind generation turbine farm, either individually or 1 2 jointly with another unit of local government, school district, or community college district that is authorized to own and 3 operate a wind generation turbine farm, that directly or 4 5 indirectly reduces the energy or other operating costs of the municipality. The municipality may ask for the assistance of 6 7 any State agency, including without limitation the Department of Commerce and Economic Opportunity, the Illinois Power 8 9 Agency, or the Environmental Protection Agency, in obtaining 10 financing options for a wind generation turbine farm.

Section 15. The School Code is amended by changing and renumbering Sections 10-20.40 and 34-18.34 as follows:
