1 AMENDMENT TO SENATE BILL 1132

2 AMENDMENT NO. _____. Amend Senate Bill 1132, AS AMENDED,
3 by replacing everything after the enacting clause with the
4 following:

5 "ARTICLE 1

6 Section 5. The sum of \$5,000,000, or so much thereof as
7 may be necessary, is appropriated from the Digital Divide
8 Elimination Infrastructure Fund for transfer into the FY09
9 Budget Relief Fund.

10 Section 10. The sum of \$2,000,000, or so much thereof as
11 may be necessary, is appropriated from the FY09 Budget Relief
12 Fund to the Department of Commerce and Economic Opportunity
13 for the Illinois Rural HealthNet.

1 administrative expenses pursuant to the Job Training and
2 Economic Development Grant Program Act of 1997, as amended.

3 Section 20. The amount of \$35,000,000, or so much
4 thereof as may be necessary, is appropriated from the Coal
5 Development Bond Fund to the Department of Commerce and
6 Economic Opportunity for the purpose of facility cost reports
7 prepared pursuant to Section 1-75(d)(4) of the Illinois Power
8 Agency Act.

9 ARTICLE 3

10 Section 5. The amount of \$11,300,000, or so much thereof
11 as may be necessary, is appropriated from the FY09 Budget
12 Relief Fund to the Office of the Secretary of State for the
13 purposes of supplementing their ordinary and contingent
14 expenses.

15 ARTICLE 4

16 Section 5. The amount of \$6,750,000, or so much thereof as
17 may be necessary, is appropriated from the FY09 Budget Relief
18 Fund to the Office of the Attorney General for the purposes
19 of supplementing their ordinary and contingent expenses.

1 ARTICLE 5

2 Section 5. The amount of \$1,079,000, or so much thereof
3 as may be necessary, is appropriated from the FY09 Budget
4 Relief Fund to the Office of the State Treasurer for the
5 purposes of supplementing their ordinary and contingent
6 expenses.

7 ARTICLE 6

8 Section 5. The sum of \$5,000,000 is appropriated from
9 the FY09 Budget Relief Fund to the Wildlife and Fish Fund.

10 Section 10. The sum of \$500,000 is appropriated from
11 the FY09 Budget Relief Fund to the Fish and Wildlife
12 Endowment Fund.

13 Section 15. The sum of \$250,000 is appropriated from
14 the FY09 Budget Relief Fund to the State Pheasant Fund.

15 Section 20. The sum of \$2,000,000 is appropriated from
16 the FY09 Budget Relief Fund to the Illinois Habitat Endowment
17 Trust Fund.

18 Section 25. The sum of \$1,000,000 is appropriated from

1 the FY09 Budget Relief Fund to the Illinois Habitat Fund.

2 Section 30. The sum of \$500,000 is appropriated from
3 the FY09 Budget Relief Fund to the State Migratory Waterfowl
4 Stamp Fund.

5 ARTICLE 99

6 Section 99. Effective date. This Act takes effect upon
7 becoming law."
