1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 Section 5. "AN ACT concerning appropriations", Public Act
5 94-798, approved May 22, 2006, is amended by changing Section
6 1 of Article 34 as follows:

7 (P.A. 94-798, Art. 34, Sec. 1)

8 Sec. 1. The following named amounts are appropriated from
9 the General Revenue Fund to the Court of Claims to pay claims
10 in conformity with awards and recommendations made by the
11 Court of Claims as follows:
