A BILL FOR

1 AN ACT making appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 Section 5. The following named amounts, or so much  
5 thereof as may be necessary, respectively, are appropriated  
6 to the Court of Claims for its ordinary and contingent  
7 expenses:

4 Section 10. The amount of \$300,000, or so much of that  
5 amount as may be necessary, is appropriated from the Court of  
6 Claims Administration and Grant Fund to the Court of Claims  
7 for administrative expenses under the Crime Victims  
8 Compensation Act.

9 Section 15. The amount of \$500,000, or so much of that  
10 amount as may be necessary, is appropriated from the General  
11 Revenue Fund to the Court of Claims for payment of awards  
12 solely as a result of the lapsing of an appropriation  
13 originally made from any funds held by the State Treasurer.

14  
15 Section 20. The sum of \$5,000,000 or so much thereof as  
16 may be necessary, is appropriated from the General Revenue  
17 Fund to the Court of Claims for payment of line of duty  
18 awards.

19 Section 25. The following named amounts, or so much of  
20 that amount as may be necessary, are appropriated to the  
21 Court of Claims for payment of claims as follows:  
22 For claims under the Crime Victims
