

1 AN ACT concerning education.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Counties Code is amended by changing Section
5 3-9005 as follows:

6 (55 ILCS 5/3-9005) (from Ch. 34, par. 3-9005)
7 Sec. 3-9005. Powers and duties of State's attorney.

8 (a) The duty of each State's attorney shall be:

9 (1) To commence and prosecute all actions, suits,
10 indictments and prosecutions, civil and criminal, in the
11 circuit court for his county, in which the people of the
12 State or county may be concerned.

13 (2) To prosecute all forfeited bonds and
14 recognizances, and all actions and proceedings for the
15 recovery of debts, revenues, moneys, fines, penalties and
16 forfeitures accruing to the State or his county, or to any
17 school district or road district in his county; also, to
18 prosecute all suits in his county against railroad or
19 transportation companies, which may be prosecuted in the
20 name of the People of the State of Illinois.

21 (3) To commence and prosecute all actions and
22 proceedings brought by any county officer in his official
23 capacity.

1 (4) To defend all actions and proceedings brought
2 against his county, or against any county or State officer,
3 in his official capacity, within his county.

4 (5) To attend the examination of all persons brought
5 before any judge on habeas corpus, when the prosecution is
6 in his county.

7 (6) To attend before judges and prosecute charges of
8 felony or misdemeanor, for which the offender is required
9 to be recognized to appear before the circuit court, when
10 in his power so to do.

11 (7) To give his opinion, without fee or reward, to any
12 county officer in his county, upon any question or law
13 relating to any criminal or other matter, in which the
14 people or the county may be concerned.

15 (8) To assist the attorney general whenever it may be
16 necessary, and in cases of appeal from his county to the
17 Supreme Court, to which it is the duty of the attorney
18 general to attend, he shall furnish the attorney general at
19 least 10 days before such is due to be filed, a manuscript
20 of a proposed statement, brief and argument to be printed
21 and filed on behalf of the people, prepared in accordance
22 with the rules of the Supreme Court. However, if such
23 brief, argument or other document is due to be filed by law
24 or order of court within this 10 day period, then the
25 State's attorney shall furnish such as soon as may be
26 reasonable.

1 (9) To pay all moneys received by him in trust, without
2 delay, to the officer who by law is entitled to the custody
3 thereof.

4 (10) To notify, by first class mail, complaining
5 witnesses of the ultimate disposition of the cases arising
6 from an indictment or an information.

7 (11) To perform such other and further duties as may,
8 from time to time, be enjoined on him by law.

9 (12) To appear in all proceedings by collectors of
10 taxes against delinquent taxpayers for judgments to sell
11 real estate, and see that all the necessary preliminary
12 steps have been legally taken to make the judgment legal
13 and binding.

14 (13) To notify, by first-class mail, the State
15 Superintendent of Education, the applicable regional
16 superintendent of schools, and the superintendent of the
17 employing school district, if any, upon the conviction of
18 any individual known to possess a certificate issued
19 pursuant to Article 21 of the School Code of any offense
20 set forth in Section 21-23a of the School Code or any other
21 felony conviction, providing the name of the certificate
22 holder, the fact of the conviction, and the name and
23 location of the court where the conviction occurred. The
24 certificate holder must also be contemporaneously sent a
25 copy of the notice.

26 (b) The State's Attorney of each county shall have

1 authority to appoint one or more special investigators to serve
2 subpoenas, make return of process and conduct investigations
3 which assist the State's Attorney in the performance of his
4 duties. A special investigator shall not carry firearms except
5 with permission of the State's Attorney and only while carrying
6 appropriate identification indicating his employment and in
7 the performance of his assigned duties.

8 Subject to the qualifications set forth in this subsection,
9 special investigators shall be peace officers and shall have
10 all the powers possessed by investigators under the State's
11 Attorneys Appellate Prosecutor's Act.

12 No special investigator employed by the State's Attorney
13 shall have peace officer status or exercise police powers
14 unless he or she successfully completes the basic police
15 training course mandated and approved by the Illinois Law
16 Enforcement Training Standards Board or such board waives the
17 training requirement by reason of the special investigator's
18 prior law enforcement experience or training or both. Any
19 State's Attorney appointing a special investigator shall
20 consult with all affected local police agencies, to the extent
21 consistent with the public interest, if the special
22 investigator is assigned to areas within that agency's
23 jurisdiction.

24 Before a person is appointed as a special investigator, his
25 fingerprints shall be taken and transmitted to the Department
26 of State Police. The Department shall examine its records and

1 submit to the State's Attorney of the county in which the
2 investigator seeks appointment any conviction information
3 concerning the person on file with the Department. No person
4 shall be appointed as a special investigator if he has been
5 convicted of a felony or other offense involving moral
6 turpitude. A special investigator shall be paid a salary and be
7 reimbursed for actual expenses incurred in performing his
8 assigned duties. The county board shall approve the salary and
9 actual expenses and appropriate the salary and expenses in the
10 manner prescribed by law or ordinance.

11 (c) The State's Attorney may request and receive from
12 employers, labor unions, telephone companies, and utility
13 companies location information concerning putative fathers and
14 noncustodial parents for the purpose of establishing a child's
15 paternity or establishing, enforcing, or modifying a child
16 support obligation. In this subsection, "location information"
17 means information about (i) the physical whereabouts of a
18 putative father or noncustodial parent, (ii) the putative
19 father or noncustodial parent's employer, or (iii) the salary,
20 wages, and other compensation paid and the health insurance
21 coverage provided to the putative father or noncustodial parent
22 by the employer of the putative father or noncustodial parent
23 or by a labor union of which the putative father or
24 noncustodial parent is a member.

25 (d) For each State fiscal year, the State's Attorney of
26 Cook County shall appear before the General Assembly and

1 request appropriations to be made from the Capital Litigation
2 Trust Fund to the State Treasurer for the purpose of providing
3 assistance in the prosecution of capital cases in Cook County
4 and for the purpose of providing assistance to the State in
5 post-conviction proceedings in capital cases under Article 122
6 of the Code of Criminal Procedure of 1963 and in relation to
7 petitions filed under Section 2-1401 of the Code of Civil
8 Procedure in relation to capital cases. The State's Attorney
9 may appear before the General Assembly at other times during
10 the State's fiscal year to request supplemental appropriations
11 from the Trust Fund to the State Treasurer.

12 (e) The State's Attorney shall have the authority to enter
13 into a written agreement with the Department of Revenue for
14 pursuit of civil liability under Section 17-1a of the Criminal
15 Code of 1961 against persons who have issued to the Department
16 checks or other orders in violation of the provisions of
17 paragraph (d) of subsection (B) of Section 17-1 of the Criminal
18 Code of 1961, with the Department to retain the amount owing
19 upon the dishonored check or order along with the dishonored
20 check fee imposed under the Uniform Penalty and Interest Act,
21 with the balance of damages, fees, and costs collected under
22 Section 17-1a of the Criminal Code of 1961 to be retained by
23 the State's Attorney. The agreement shall not affect the
24 allocation of fines and costs imposed in any criminal
25 prosecution.

1 Section 10. The School Code is amended by changing Sections
2 3-11, 10-21.9, 10-22.39, 21-1, 21-23, 21-23a, and 34-18.5 as
3 follows:

4 (105 ILCS 5/3-11) (from Ch. 122, par. 3-11)

5 Sec. 3-11. Institutes or inservice training workshops. In
6 counties of less than 2,000,000 inhabitants, the regional
7 superintendent may arrange for or conduct district, regional,
8 or county institutes, or equivalent professional educational
9 experiences, not more than 4 days annually. Of those 4 days, 2
10 days may be used as a teacher's workshop, when approved by the
11 regional superintendent, up to 2 days may be used for
12 conducting parent-teacher conferences or up to 2 days may be
13 utilized as parental institute days as provided in Section
14 10-22.18d. A school district may use one of its 4 institute
15 days on the last day of the school term. "Institute" or
16 "Professional educational experiences" means any educational
17 gathering, demonstration of methods of instruction, visitation
18 of schools or other institutions or facilities, sexual abuse
19 and sexual assault awareness seminar, or training in First Aid
20 (which may include cardiopulmonary resuscitation or
21 defibrillator training) held or approved by the regional
22 superintendent and declared by him to be an institute day, or
23 parent-teacher conferences. With the concurrence of the State
24 Superintendent of Education, he or she may employ such

1 assistance as is necessary to conduct the institute. Two or
2 more adjoining counties may jointly hold an institute.
3 Institute instruction shall be free to holders of certificates
4 good in the county or counties holding the institute, and to
5 those who have paid an examination fee and failed to receive a
6 certificate.

7 In counties of 2,000,000 or more inhabitants, the regional
8 superintendent may arrange for or conduct district, regional,
9 or county inservice training workshops, or equivalent
10 professional educational experiences, not more than 4 days
11 annually. Of those 4 days, 2 days may be used for conducting
12 parent-teacher conferences and up to 2 days may be utilized as
13 parental institute days as provided in Section 10-22.18d. A
14 school district may use one of those 4 days on the last day of
15 the school term. "Inservice Training Workshops" or
16 "Professional educational experiences" means any educational
17 gathering, demonstration of methods of instruction, visitation
18 of schools or other institutions or facilities, sexual abuse
19 and sexual assault awareness seminar, or training in First Aid
20 (which may include cardiopulmonary resuscitation or
21 defibrillator training) held or approved by the regional
22 superintendent and declared by him to be an inservice training
23 workshop, or parent-teacher conferences. With the concurrence
24 of the State Superintendent of Education, he may employ such
25 assistance as is necessary to conduct the inservice training
26 workshop. With the approval of the regional superintendent, 2

1 or more adjoining districts may jointly hold an inservice
2 training workshop. In addition, with the approval of the
3 regional superintendent, one district may conduct its own
4 inservice training workshop with subject matter consultants
5 requested from the county, State or any State institution of
6 higher learning.

7 Such teachers institutes as referred to in this Section may
8 be held on consecutive or separate days at the option of the
9 regional superintendent having jurisdiction thereof.

10 Whenever reference is made in this Act to "teachers
11 institute", it shall be construed to include the inservice
12 training workshops or equivalent professional educational
13 experiences provided for in this Section.

14 Any institute advisory committee existing on April 1, 1995,
15 is dissolved and the duties and responsibilities of the
16 institute advisory committee are assumed by the regional office
17 of education advisory board.

18 Districts providing inservice training programs shall
19 constitute inservice committees, 1/2 of which shall be
20 teachers, 1/4 school service personnel and 1/4 administrators
21 to establish program content and schedules.

22 The teachers institutes shall include teacher training
23 committed to (i) peer counseling programs and other
24 anti-violence and conflict resolution programs, including
25 without limitation programs for preventing at risk students
26 from committing violent acts, and (ii) educator ethics and

1 teacher-student conduct.

4 Sec. 10-21.9. Criminal history records checks and checks of
5 the Statewide Sex Offender Database and Statewide Child
6 Murderer and Violent Offender Against Youth Database.

7 (a) Certified and noncertified applicants for employment
8 with a school district, except school bus driver applicants,
9 are required as a condition of employment to authorize a
10 fingerprint-based criminal history records check to determine
11 if such applicants have been convicted of any of the enumerated
12 criminal or drug offenses in subsection (c) of this Section or
13 have been convicted, within 7 years of the application for
14 employment with the school district, of any other felony under
15 the laws of this State or of any offense committed or attempted
16 in any other state or against the laws of the United States
17 that, if committed or attempted in this State, would have been
18 punishable as a felony under the laws of this State.
19 Authorization for the check shall be furnished by the applicant
20 to the school district, except that if the applicant is a
21 substitute teacher seeking employment in more than one school
22 district, a teacher seeking concurrent part-time employment
23 positions with more than one school district (as a reading
24 specialist, special education teacher or otherwise), or an
25 educational support personnel employee seeking employment

1 positions with more than one district, any such district may
2 require the applicant to furnish authorization for the check to
3 the regional superintendent of the educational service region
4 in which are located the school districts in which the
5 applicant is seeking employment as a substitute or concurrent
6 part-time teacher or concurrent educational support personnel
7 employee. Upon receipt of this authorization, the school
8 district or the appropriate regional superintendent, as the
9 case may be, shall submit the applicant's name, sex, race, date
10 of birth, social security number, fingerprint images, and other
11 identifiers, as prescribed by the Department of State Police,
12 to the Department. The regional superintendent submitting the
13 requisite information to the Department of State Police shall
14 promptly notify the school districts in which the applicant is
15 seeking employment as a substitute or concurrent part-time
16 teacher or concurrent educational support personnel employee
17 that the check of the applicant has been requested. The
18 Department of State Police and the Federal Bureau of
19 Investigation shall furnish, pursuant to a fingerprint-based
20 criminal history records check, records of convictions, until
21 expunged, to the president of the school board for the school
22 district that requested the check, or to the regional
23 superintendent who requested the check. The Department shall
24 charge the school district or the appropriate regional
25 superintendent a fee for conducting such check, which fee shall
26 be deposited in the State Police Services Fund and shall not

1 exceed the cost of the inquiry; and the applicant shall not be
2 charged a fee for such check by the school district or by the
3 regional superintendent. Subject to appropriations for these
4 purposes, the State Superintendent of Education shall
5 reimburse school districts and regional superintendents for
6 fees paid to obtain criminal history records checks under this
7 Section.

8 (a-5) The school district or regional superintendent shall
9 further perform a check of the Statewide Sex Offender Database,
10 as authorized by the Sex Offender Community Notification Law,
11 for each applicant.

12 (a-6) The school district or regional superintendent shall
13 further perform a check of the Statewide Child Murderer and
14 Violent Offender Against Youth Database, as authorized by the
15 Child Murderer and Violent Offender Against Youth Community
16 Notification Law, for each applicant.

17 (b) Any information concerning the record of convictions
18 obtained by the president of the school board or the regional
19 superintendent shall be confidential and may only be
20 transmitted to the superintendent of the school district or his
21 designee, the appropriate regional superintendent if the check
22 was requested by the school district, the presidents of the
23 appropriate school boards if the check was requested from the
24 Department of State Police by the regional superintendent, the
25 State Superintendent of Education, the State Teacher
26 Certification Board or any other person necessary to the

1 decision of hiring the applicant for employment. A copy of the
2 record of convictions obtained from the Department of State
3 Police shall be provided to the applicant for employment. Upon
4 the check of the Statewide Sex Offender Database, the school
5 district or regional superintendent shall notify an applicant
6 as to whether or not the applicant has been identified in the
7 Database as a sex offender. If a check of an applicant for
8 employment as a substitute or concurrent part-time teacher or
9 concurrent educational support personnel employee in more than
10 one school district was requested by the regional
11 superintendent, and the Department of State Police upon a check
12 ascertains that the applicant has not been convicted of any of
13 the enumerated criminal or drug offenses in subsection (c) or
14 has not been convicted, within 7 years of the application for
15 employment with the school district, of any other felony under
16 the laws of this State or of any offense committed or attempted
17 in any other state or against the laws of the United States
18 that, if committed or attempted in this State, would have been
19 punishable as a felony under the laws of this State and so
20 notifies the regional superintendent and if the regional
21 superintendent upon a check ascertains that the applicant has
22 not been identified in the Sex Offender Database as a sex
23 offender, then the regional superintendent shall issue to the
24 applicant a certificate evidencing that as of the date
25 specified by the Department of State Police the applicant has
26 not been convicted of any of the enumerated criminal or drug

1 offenses in subsection (c) or has not been convicted, within 7
2 years of the application for employment with the school
3 district, of any other felony under the laws of this State or
4 of any offense committed or attempted in any other state or
5 against the laws of the United States that, if committed or
6 attempted in this State, would have been punishable as a felony
7 under the laws of this State and evidencing that as of the date
8 that the regional superintendent conducted a check of the
9 Statewide Sex Offender Database, the applicant has not been
10 identified in the Database as a sex offender. The school board
11 of any school district may rely on the certificate issued by
12 any regional superintendent to that substitute teacher,
13 concurrent part-time teacher, or concurrent educational
14 support personnel employee or may initiate its own criminal
15 history records check of the applicant through the Department
16 of State Police and its own check of the Statewide Sex Offender
17 Database as provided in subsection (a). Any person who releases
18 any confidential information concerning any criminal
19 convictions of an applicant for employment shall be guilty of a
20 Class A misdemeanor, unless the release of such information is
21 authorized by this Section.

22 (c) No school board shall knowingly employ a person who has
23 been convicted of any offense that would subject him or her to
24 certification suspension or revocation pursuant to Section
25 21-23a of this Code. ~~for committing attempted first degree~~
26 ~~murder or for committing or attempting to commit first degree~~

1 ~~murder or a Class X felony or any one or more of the following~~
2 ~~offenses: (i) those defined in Sections 11-6, 11-9, 11-14,~~
3 ~~11-15, 11-15.1, 11-16, 11-17, 11-18, 11-19, 11-19.1, 11-19.2,~~
4 ~~11-20, 11-20.1, 11-21, 12-13, 12-14, 12-14.1, 12-15 and 12-16~~
5 ~~of the Criminal Code of 1961; (ii) those defined in the~~
6 ~~Cannabis Control Act except those defined in Sections 4(a),~~
7 ~~4(b) and 5(a) of that Act; (iii) those defined in the Illinois~~
8 ~~Controlled Substances Act; (iv) those defined in the~~
9 ~~Methamphetamine Control and Community Protection Act; and (v)~~
10 ~~any offense committed or attempted in any other state or~~
11 ~~against the laws of the United States, which if committed or~~
12 ~~attempted in this State, would have been punishable as one or~~
13 ~~more of the foregoing offenses.~~ Further, no school board shall
14 knowingly employ a person who has been found to be the
15 perpetrator of sexual or physical abuse of any minor under 18
16 years of age pursuant to proceedings under Article II of the
17 Juvenile Court Act of 1987.

18 (d) No school board shall knowingly employ a person for
19 whom a criminal history records check and a Statewide Sex
20 Offender Database check has not been initiated.

21 (e) Upon receipt of the record of a conviction of or a
22 finding of child abuse by a holder of any certificate issued
23 pursuant to Article 21 or Section 34-8.1 or 34-83 of the School
24 Code, the ~~appropriate regional superintendent of schools or the~~
25 State Superintendent of Education may ~~shall~~ initiate ~~the~~
26 certificate suspension and revocation proceedings as

1 authorized by law.

2 (e-5) The superintendent of the employing school board
3 shall, in writing, notify the State Superintendent of Education
4 and the applicable regional superintendent of schools of any
5 certificate holder whom he or she has reasonable cause to
6 believe has committed an intentional act of abuse or neglect
7 with the result of making a child an abused child or a
8 neglected child, as defined in Section 3 of the Abused and
9 Neglected Child Reporting Act, and that act resulted in the
10 certificate holder's dismissal or resignation from the school
11 district. This notification must be submitted within 30 days
12 after the dismissal or resignation. The certificate holder must
13 also be contemporaneously sent a copy of the notice by the
14 superintendent. All correspondence, documentation, and other
15 information so received by the regional superintendent of
16 schools, the State Superintendent of Education, the State Board
17 of Education, or the State Teacher Certification Board under
18 this subsection (e-5) is confidential and must not be disclosed
19 to third parties, except (i) as necessary for the State
20 Superintendent of Education or his or her designee to
21 investigate and prosecute pursuant to Article 21 of this Code,
22 (ii) pursuant to a court order, (iii) for disclosure to the
23 certificate holder or his or her representative, or (iv) as
24 otherwise provided in this Article and provided that any such
25 information admitted into evidence in a hearing is exempt from
26 this confidentiality and non-disclosure requirement. Except

1 for an act of willful or wanton misconduct, any superintendent
2 who provides notification as required in this subsection (e-5)
3 shall have immunity from any liability, whether civil or
4 criminal or that otherwise might result by reason of such
5 action.

6 (f) After January 1, 1990 the provisions of this Section
7 shall apply to all employees of persons or firms holding
8 contracts with any school district including, but not limited
9 to, food service workers, school bus drivers and other
10 transportation employees, who have direct, daily contact with
11 the pupils of any school in such district. For purposes of
12 criminal history records checks and checks of the Statewide Sex
13 Offender Database on employees of persons or firms holding
14 contracts with more than one school district and assigned to
15 more than one school district, the regional superintendent of
16 the educational service region in which the contracting school
17 districts are located may, at the request of any such school
18 district, be responsible for receiving the authorization for a
19 criminal history records check prepared by each such employee
20 and submitting the same to the Department of State Police and
21 for conducting a check of the Statewide Sex Offender Database
22 for each employee. Any information concerning the record of
23 conviction and identification as a sex offender of any such
24 employee obtained by the regional superintendent shall be
25 promptly reported to the president of the appropriate school
26 board or school boards.

5 Sec. 10-22.39. In-service training programs.

6 (a) To conduct in-service training programs for teachers.

7 (b) In addition to other topics at in-service training
8 programs, school guidance counselors, teachers and other
9 school personnel who work with pupils in grades 7 through 12
10 shall be trained to identify the warning signs of suicidal
11 behavior in adolescents and teens and shall be taught
12 appropriate intervention and referral techniques.

13 (c) School guidance counselors, nurses, teachers and other
14 school personnel who work with pupils may be trained to have a
15 basic knowledge of matters relating to acquired
16 immunodeficiency syndrome (AIDS), including the nature of the
17 disease, its causes and effects, the means of detecting it and
18 preventing its transmission, and the availability of
19 appropriate sources of counseling and referral, and any other
20 information that may be appropriate considering the age and
21 grade level of such pupils. The School Board shall supervise
22 such training. The State Board of Education and the Department
23 of Public Health shall jointly develop standards for such
24 training.

25 (d) In this subsection (d):

1 "Domestic violence" means abuse by a family or household
2 member, as "abuse" and "family or household members" are
3 defined in Section 103 of the Illinois Domestic Violence Act of
4 1986.

5 "Sexual violence" means sexual assault, abuse, or stalking
6 of an adult or minor child proscribed in the Criminal Code of
7 1961 in Sections 12-7.3, 12-7.4, 12-7.5, 12-12, 12-13, 12-14,
8 12-14.1, 12-15, and 12-16, including sexual violence committed
9 by perpetrators who are strangers to the victim and sexual
10 violence committed by perpetrators who are known or related by
11 blood or marriage to the victim.

12 At least once every 2 years, an in-service training program
13 for school personnel who work with pupils, including, but not
14 limited to, school and school district administrators,
15 teachers, school guidance counselors, school social workers,
16 school counselors, school psychologists, and school nurses,
17 must be conducted by persons with expertise in domestic and
18 sexual violence and the needs of expectant and parenting youth
19 and shall include training concerning (i) communicating with
20 and listening to youth victims of domestic or sexual violence
21 and expectant and parenting youth, (ii) connecting youth
22 victims of domestic or sexual violence and expectant and
23 parenting youth to appropriate in-school services and other
24 agencies, programs, and services as needed, and (iii)
25 implementing the school district's policies, procedures, and
26 protocols with regard to such youth, including

1 confidentiality. At a minimum, school personnel must be trained
2 to understand, provide information and referrals, and address
3 issues pertaining to youth who are parents, expectant parents,
4 or victims of domestic or sexual violence.

5 (e) At least once every 2 years, a school board shall
6 conduct in-service training on educator ethics,
7 teacher-student conduct, and school employee-student conduct
8 for all personnel.

10 (105 ILCS 5/21-1) (from Ch. 122, par. 21-1)

11 Sec. 21-1. Qualification of teachers. No one may be
12 certified to teach or supervise in the public schools of this
13 State who is not of good character, of good health, a citizen
14 of the United States or legally present and authorized for
15 employment, and at least 19 years of age. No one may be
16 certified to teach or supervise in the public schools of this
17 State who has been convicted of an offense set forth in Section
18 21-23a of this Code. An applicant for a certificate who is not
19 a citizen of the United States must sign and file with the
20 State Board of Education a letter of intent indicating that
21 either (i) within 10 years after the date that the letter is
22 filed or (ii) at the earliest opportunity after the person
23 becomes eligible to apply for U.S. citizenship, the person will
24 apply for U.S. citizenship.

25 Citizenship is not required for the issuance of a temporary

1 part-time certificate to participants in approved training

19 ~~4(a), 4(b) and 5(a) of that Act; (iii) those defined in the~~
20 ~~Illinois Controlled Substances Act; (iv) those defined in the~~
21 ~~Methamphetamine Control and Community Protection Act; and (v)~~
22 ~~any offense committed or attempted in any other state or~~
23 ~~against the laws of the United States, which if committed or~~
24 ~~attempted in this State, would have been punishable as one or~~
25 ~~more of the foregoing offenses.~~ Further, the board of education
26 shall not knowingly employ a person who has been found to be

1 the perpetrator of sexual or physical abuse of any minor under
2 18 years of age pursuant to proceedings under Article II of the
3 Juvenile Court Act of 1987.

4 (d) The board of education shall not knowingly employ a
5 person for whom a criminal history records check and a
6 Statewide Sex Offender Database check has not been initiated.

7 (e) Upon receipt of the record of a conviction of or a
8 finding of child abuse by a holder of any certificate issued
9 pursuant to Article 21 or Section 34-8.1 or 34-83 of the School
10 Code, the ~~board of education or the~~ State Superintendent of
11 Education may ~~shall~~ initiate ~~the~~ certificate suspension and
12 revocation proceedings as authorized by law.

13 (e-5) The general superintendent of schools shall, in
14 writing, notify the State Superintendent of Education of any
15 certificate holder whom he or she has reasonable cause to
16 believe has committed an intentional act of abuse or neglect
17 with the result of making a child an abused child or a
18 neglected child, as defined in Section 3 of the Abused and
19 Neglected Child Reporting Act, and that act resulted in the
20 certificate holder's dismissal or resignation from the school
21 district. This notification must be submitted within 30 days
22 after the dismissal or resignation. The certificate holder must
23 also be contemporaneously sent a copy of the notice by the
24 superintendent. All correspondence, documentation, and other
25 information so received by the State Superintendent of
26 Education, the State Board of Education, or the State Teacher

1 Certification Board under this subsection (e-5) is
2 confidential and must not be disclosed to third parties, except
3 (i) as necessary for the State Superintendent of Education or
4 his or her designee to investigate and prosecute pursuant to
5 Article 21 of this Code, (ii) pursuant to a court order, (iii)
6 for disclosure to the certificate holder or his or her
7 representative, or (iv) as otherwise provided in this Article
8 and provided that any such information admitted into evidence
9 in a hearing is exempt from this confidentiality and
10 non-disclosure requirement. Except for an act of willful or
11 wanton misconduct, any superintendent who provides
12 notification as required in this subsection (e-5) shall have
13 immunity from any liability, whether civil or criminal or that
14 otherwise might result by reason of such action.

15 (f) After March 19, 1990, the provisions of this Section
16 shall apply to all employees of persons or firms holding
17 contracts with any school district including, but not limited
18 to, food service workers, school bus drivers and other
19 transportation employees, who have direct, daily contact with
20 the pupils of any school in such district. For purposes of
21 criminal history records checks and checks of the Statewide Sex
22 Offender Database on employees of persons or firms holding
23 contracts with more than one school district and assigned to
24 more than one school district, the regional superintendent of
25 the educational service region in which the contracting school
26 districts are located may, at the request of any such school

1 district, be responsible for receiving the authorization for a
2 criminal history records check prepared by each such employee
3 and submitting the same to the Department of State Police and
4 for conducting a check of the Statewide Sex Offender Database
5 for each employee. Any information concerning the record of
6 conviction and identification as a sex offender of any such
7 employee obtained by the regional superintendent shall be
8 promptly reported to the president of the appropriate school
9 board or school boards.
