1 AMENDMENT TO SENATE BILL 2512 AMENDMENT NO. . Amend Senate Bill 2512 by replacing 2 everything after the enacting clause with the following: 3 "Section 5. The School Code is amended by changing Section 4 27-13.3 as follows: 5 6 (105 ILCS 5/27-13.3) 7 Sec. 27-13.3. Internet safety education curriculum. (a) The purpose of this Section is to inform and protect 8 students from inappropriate or illegal communications and 9 10 solicitation and to encourage school districts to provide education about Internet threats and risks, including without 11 12 limitation child predators, fraud, and other dangers. 13 (b) The General Assembly finds and declares the following: (1) it is the policy of this State to protect consumers 14 15 Illinois residents from deceptive and

- (2) children have easy access to the Internet at home, school, and public places;
 - (3) the Internet is used by sexual predators and other criminals to make initial contact with children and other vulnerable residents in Illinois; and
 - (4) education is an effective method for preventing children from falling prey to online predators, identity theft, and other dangers.
- (c) Each school may adopt an age-appropriate curriculum for Internet safety instruction of students in grades kindergarten through 12. However, beginning with the 2009-2010 school year, a school district must incorporate into the school curriculum a component on Internet safety to be taught at least once each school year to students in grade 3 or above. It is hereby recommended that the age-appropriate curriculum for Internet safety instruction provide for a minimum of 2 hours of Internet safety education each school year that includes instruction on each of the following topics:
 - (1) Safe and responsible use of social networking websites, chat rooms, electronic mail, bulletin boards, instant messaging, and other means of communication on the Internet.
- (2) Recognizing, avoiding, and reporting online solicitations of students, their classmates, and their friends by sexual predators.

- (4) Recognizing and avoiding unsolicited or deceptive communications received online.
- 5 (5) Recognizing and reporting online harassment and cyber-bullying.
 - (6) Reporting illegal activities and communications on the Internet.
- 9 (7) Copyright laws on written materials, photographs, 10 music, and video.
- 11 (d) Curricula devised in accordance with subsection (c) of 12 this Section may be submitted for review to the Office of the 13 Illinois Attorney General.
- 14 (e) The State Board of Education shall make available 15 resource materials for educating children regarding child 16 online safety and may take into consideration the curriculum on this subject developed by other states, as well as any other 17 curricular materials suggested by education experts, child 18 psychologists, or technology companies that work on child 19 20 online safety issues. Materials may include without limitation safe online communications, privacy protection, 21 22 cyber-bullying, viewing inappropriate material, file sharing, and the importance of open communication with responsible 23 24 adults. The State Board of Education shall make these resource 25 materials available on its Internet website.
