5 Whenever it becomes necessary for the State or governmental unit to furnish in a disaster area emergency 6 services directly related to or required by a disaster and 7 existing funds are insufficient to provide such services, the 8 9 Governor may, when he considers such action in the best 10 interest of the State, release funds from the General Revenue disaster relief appropriation in order to provide such 11 12 services or to reimburse local governmental bodies furnishing such services. Such appropriation may be used for payment of 13 the Illinois National Guard when called to active duty in 14 15 case of disaster, and for the emergency purchase or renting of equipment and commodities. Such appropriation shall be 16 17 used for emergency services and relief to the disaster area as a whole and shall not be used to provide private relief to 18 persons sustaining property damages or personal injury as a 19 20 result of a disaster.

Section 45. The sum of \$1,060,000, or so much thereof as 1 necessary, is appropriated from the 2 Radiation Protection Fund to the Illinois Emergency Management Agency 3 licensing facilities where radioactive uranium 5 thorium mill tailings are generated or located, and related costs for regulating the decontamination and decommissioning 6 of such facilities and for identification, decontamination 7 environmental monitoring of unlicensed properties 8 and contaminated with such radioactive mill tailings. 9

Section 50. The sum of \$561,000, or so much thereof as 10 11 be necessary, is appropriated from the Radiation Protection Fund to the Illinois Emergency Management Agency 12 for the purpose of funding costs related to environmental 13 14 cleanup of the Ottawa Radiation Areas Superfund Project under cooperative agreements with the Federal Government. 15

16 Section 55. The sum of \$150,000, or so much thereof as may be necessary, is appropriated from 17 the Radiation 18 Protection Fund to the Illinois Emergency Management Agency for recovery and remediation of radioactive materials and 19 contaminated facilities or properties when such expenses 20 21 cannot be paid by a responsible person or an available 22 surety.

- Section 60. The sum of \$150,000, or so much thereof as may be necessary, is appropriated from the Radiation Protection Fund to the Illinois Emergency Management Agency for local responder training, demonstrations, research, studies and investigations under funding agreements with the Federal Government.
- Section 65. The sum of \$100,000, or so much thereof as 7 8 may be necessary, is appropriated from the Nuclear Safety 9 Emergency Preparedness Fund to the Illinois Emergency Management Agency for related training and travel expenses 10 and to reimburse the Illinois State Police and the Illinois 11 Commerce Commission for costs incurred for activities related 12 to inspecting and escorting shipments of spent nuclear fuel, 13 14 high-level radioactive waste, and transuranic waste 15 Illinois as provided under the rules of the Agency.
- Section 70. The sum of \$215,000, or so much thereof as may be necessary, is appropriated from the Sheffield Agreed
  Order Fund to the Illinois Emergency Management Agency for the care, maintenance, monitoring, testing, remediation and insurance of the low-level radioactive waste disposal site near Sheffield, Illinois.

- 1 Section 75. The sum of \$602,000, or so much thereof as 2 be necessary, is appropriated from the Low-Level Radioactive Waste Facility Development and Operation Fund to 3 Emergency Management Agency for use Illinois 4 accordance with Section 14(a) of the Illinois Low-Level 5 6 Radioactive Waste Management Act for costs related establishing a low-level radioactive waste disposal facility.
- Section 80. The sum of \$426,500, or so much thereof as 8 9 may be necessary, is appropriated from the General Revenue 10 Fund to the Illinois Emergency Management Agency for costs and expenses related to or in support of a public safety 11 12 shared services center.
- The sum of \$153,600, or so much thereof as 13 Section 85. 14 necessary, is appropriated from the Radiation Protection Fund to the Illinois Emergency Management Agency 15 16 for costs and expenses related to or in support of a public safety shared services center. 17
- 18 Section 90. The sum of \$465,000, or so much thereof as may be necessary, is appropriated from the 19 Emergency Management Preparedness Fund to the Illinois 20 Emergency 21 Management Agency for costs and expenses related to or in support of a public safety shared services center. 22

- 1 Section 95. The sum of \$951,000, or so much thereof as
- 2 may be necessary, is appropriated from the Nuclear Safety
- 3 Emergency Preparedness Fund to the Illinois Emergency
- 4 Management Agency for costs and expenses related to or in
- 5 support of a public safety shared services center.
- 6 Section 99. Effective Date. This Act takes effect July
