A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following amounts, or so much thereof as
6 may be necessary, respectively, are appropriated for the
7 objects and purposes named, to meet the ordinary and
8 contingent expenses of the Illinois Violence Prevention
9 Authority:

10 Payable from the Violence Prevention Fund:

12	For State Contributions to State

6 Section 10. The sum of \$1,200,000, or so much thereof as
7 may be necessary, is appropriated from the Violence
8 Prevention Fund to the Illinois Violence Prevention Authority
9 for the purpose of awarding grants under the provisions of
10 the Violence Prevention Act of 1995.

11 Section 15. The sum of \$2,127,500, or so much thereof as
12 may be necessary, is appropriated from the General Revenue
13 Fund to the Illinois Violence Prevention Authority for the
14 purpose of awarding grants under the provisions of the
15 Violence Prevention Act of 1995.

16 Section 20. The amount of \$849,600, or so much of that
17 amount as may be necessary, is appropriated from the General
18 Revenue Fund to the Illinois Violence Prevention Authority
19 for the Illinois Family Violence Coordinating Council
20 Program.

21 Section 25. The amount of \$1,000,000, or so much thereof

1 as may be necessary, is appropriated from the General Revenue
2 Fund to the Illinois Violence Prevention Authority for all
3 costs associated with Bullying Prevention.

4 Section 99. Effective Date. This Act takes effect July
5 1, 2008.
