1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named sums, or so much thereof
6 as may be necessary, respectively, for the objects and
7 purposes hereinafter named, are appropriated to meet the
8 ordinary and contingent expenses of the Department of Labor:

4 Section 25. In addition to any other funds appropriated
 5 for that purpose, the sum of \$259,500 is appropriated from
 6 the General Revenue Fund to the Department of Labor for all
 7 costs associated with promoting and enforcing the Equal Pay
 8 Act and the Victims Economic Security and Safety Act.

9 Section 30. The amount of \$1,500,000, or so much thereof
 10 as may be necessary, is appropriated from the Department of
 11 Labor Federal Trust Fund to the Department of Labor for all
 12 costs associated with promoting and enforcing the
 13 occupational safety and health administration state program
 14 for public sector worksites.

15 Section 99. Effective date. This Act takes effect July 1,
 16 2009.
