## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1

Section 10. The amount of \$50,000, or so much thereof as may be necessary, is appropriated from the State College and University Fund to the Board of Trustees of Illinois State University for scholarship grant awards from the sale of collegiate license plates.

Section 15. In addition to any other appropriated for such purposes, the following named amounts, or so much thereof as may be necessary, are appropriated from the General Revenue Fund to the Board of Trustees of Illinois State University for the fiscal year beginning July 1, 2009, pursuant to Title XIV of the American Recovery Reinvestment Act of 2009:
