Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 1 Section 65. The sum of \$750,000, or so much thereof as
- 2 may be necessary, is appropriated from the ISBE GED Testing
- 3 Fund to the Illinois Community College Board for costs
- 4 associated with administering GED tests.
- 5 Section 70. The sum of \$300,000, or so much thereof as
- 6 may be necessary, is appropriated from ICCB Instruction
- 7 Development and Enhancement Applications Revolving Fund to
- 8 the Illinois Community College Board for costs associated
- 9 with maintaining and updating instructional technology.
- Section 75. The sum of \$7,261,500, or so much thereof as
- 11 may be necessary, is appropriated from the General Revenue
- 12 Fund to the Illinois Community College Board to reimburse
- 13 colleges up to 50 percent of the costs associated with the
- 14 Illinois Veterans' Grant.
- 15 Section 80. The sum of \$750,000, or so much thereof as
- 16 may be necessary, is appropriated from the General Revenue
- 17 Fund to the Illinois Community College Board for costs
- 18 associated with the College and Career Readiness Pilot
- 19 Program.
- 20 Section 99. Effective date. This Act takes effect July 1,
- 21 2010.
