 - (3) with a wire seal on the mainline disconnect switch installed by a licensed elevator inspector;
 - (4) that shall not be used again until it has been put in safe running order and is in condition for use;
 - (5) requiring annual inspections for the duration of the temporarily dormant status by a licensed elevator inspector;
 - (6) that has a "temporarily dormant" status that is renewable on an annual basis, not to exceed a 5-year period;
 - (7) requiring the inspector to file a report with the Administrator describing the current conditions; and

Any person certified by a licensed elevator contractor to have an acceptable combination of documented experience and education to perform elevator work without direct and immediate supervision shall seek an emergency elevator mechanic's license from the Administrator within 5 business days after commencing work requiring a license. The Administrator shall renew an emergency elevator mechanic's license during the existence of an emergency. No fee may be charged for any emergency elevator mechanic's license or renewal thereof.

(a) The Administrator may enter into a local elevator agreement contracts with municipalities or counties under which the Local Administrator municipalities or counties shall (i) issue construction permits and certificates of operation, (ii) provide for inspection of elevators, including temporary operation inspections, (iii) grant exceptions and variances from the literal requirements of applicable State codes, standards, and regulations in cases where such variances would not jeopardize the public safety and welfare, and (iv) (iii) enforce the applicable provisions of the Act, and levy fines in accordance with the Municipal Code or Counties Code. The Local Administrator municipality or county may choose to require that inspections be performed by its own inspectors or by private certified elevator inspectors. The Local Administrator municipality or county may assess a reasonable fee for permits, exceptions, variances, certification of operation, or Each <u>agreement</u> inspections performed by its inspectors. contract shall include a provision that the Local Administrator municipality or county shall maintain for inspection by the Administrator copies of all applications for permits issued, grants or denials of exceptions or variances, copies of each inspection report issued, and proper records showing the number of certificates of operation issued. Each agreement contract shall also include a provision that each required inspection be

- conducted by a certified elevator inspector and any other 1 2 provisions deemed necessary by the Administrator. Any safety standards or regulations adopted by a municipality or county 3 under this subsection must be at least as stringent as those 5 provided for in this Act and the rules adopted under this Act.
