1 AMENDMENT TO SENATE BILL 934

2 AMENDMENT NO. \_\_\_\_\_. Amend Senate Bill 934 by replacing  
3 everything after the enacting clause with the following:

4 "Section 5. The State Finance Act is amended by adding  
5 Section 5.755 as follows:

6 (30 ILCS 105/5.755 new)

7 Sec. 5.755. The Workers Memorial Construction and  
8 Maintenance Fund.

9 Section 10. The Illinois Vehicle Code is amended by adding  
10 Section 3-689 as follows:

11 (625 ILCS 5/3-689 new)

12 Sec. 3-689. Trade Union license plates.

13 (a) The Secretary, upon receipt of an application made in  
14 the form prescribed by the Secretary, may issue special

1 registration plates designated as Trade Union license plates.  
2 The special plates issued under this Section shall be affixed  
3 only to passenger vehicles of the first division and motor  
4 vehicles of the second division weighing not more than 8,000  
5 pounds. Plates issued under this Section shall expire according  
6 to the multi-year procedure established by Section 3-414.1 of  
7 this Code.

8 (b) The design and color of the plates is wholly within the  
9 discretion of the Secretary. Appropriate documentation, as  
10 determined by the Secretary, shall accompany each application.  
11 The Secretary may allow the plates to be issued as vanity  
12 plates or personalized under Section 3-405.1 of the Code. The  
13 Secretary shall prescribe stickers or decals as provided under  
14 Section 3-412 of this Code. The Secretary may, in his or her  
15 discretion, allow the plates to be issued as vanity or  
16 personalized plates in accordance with Section 3-405.1 of this  
17 Code.

18 (c) An applicant for the special plate shall be charged a  
19 \$25 fee for original issuance in addition to the appropriate  
20 registration fee. Of this fee, \$10 shall be deposited into the  
21 Workers Memorial Construction and Maintenance Fund and \$15  
22 shall be deposited into the Secretary of State Special License  
23 Plate Fund, to be used by the Secretary to help defray the  
24 administrative processing costs.

25 For each registration renewal period, a \$25 fee, in  
26 addition to the appropriate registration fee, shall be charged.

1 Of this fee, \$23 shall be deposited into the Workers Memorial  
2 Construction and Maintenance Fund and \$2 shall be deposited  
3 into the Secretary of State Special License Plate Fund.

4 (d) The Workers Memorial Construction and Maintenance Fund  
5 is created as a special fund in the State treasury. All money  
6 in the Workers Memorial Construction and Maintenance Fund shall  
7 be paid, subject to appropriation, as grants for the  
8 construction and maintenance of worker memorials throughout  
9 the State of Illinois."
