A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated to meet the
8 ordinary and contingent expenses of the Illinois Criminal
9 Justice Information Authority:

17 Section 15. The sum of \$40,000,000, or so much thereof
18 as may be necessary, is appropriated from the Criminal
19 Justice Trust Fund to the Illinois Criminal Justice
20 Information Authority for awards and grants to local units of
21 government and non-profit organizations.

22 Section 20. The additional sum of \$100,000, or so much

1 thereof as may be necessary, is appropriated from the
2 Criminal Justice Information Trust Fund to the Illinois
3 Criminal Justice Information Authority for Crime Victims
4 Assistance awards and grants to local units of government and
5 non-profit organizations in accordance with applicable laws
6 and regulations for the State portion of federal funds made
7 available by the American Recovery and Reinvestment Act of
8 2009.

9 Section 25. The additional sum of \$3,000,000, or so much
10 thereof as may be necessary, is appropriated from the
11 Criminal Justice Information Trust Fund to the Illinois
12 Criminal Justice Information Authority for Violence Against
13 Women awards and grants to local units of government and non-
14 profit organizations in accordance with applicable laws and
15 regulations for the State portion of federal funds made
16 available by the American Recovery and Reinvestment Act of
17 2009.

18 Section 30. The additional sum of \$23,000,000, or so
19 much thereof as may be necessary, is appropriated from the
20 Criminal Justice Information Trust Fund to the Illinois
21 Criminal Justice Information Authority for Byrne/JAG awards
22 and grants to local units of government and non-profit
23 organizations in accordance with applicable laws and

1 regulations for the State portion of federal funds made
2 available by the American Recovery and Reinvestment Act of
3 2009.

4 Section 35. The sum of \$12,000,000, or so much thereof
5 as may be necessary, is appropriated from the Criminal
6 Justice Trust Fund to the Illinois Criminal Justice
7 Information Authority for awards and grants to state
8 agencies.

9 Section 40. The additional sum of \$1,300,000, or so much
10 thereof as may be necessary, is appropriated from the
11 Criminal Justice Trust Fund to the Illinois Criminal Justice
12 Information Authority for Crime Victims Assistance awards and
13 grants to state agencies in accordance with applicable laws
14 and regulations for the State portion of federal funds made
15 available by the American Recovery and Reinvestment Act of
16 2009.

17 Section 45. The additional sum of \$1,000,000, or so much
18 thereof as may be necessary, is appropriated from the
19 Criminal Justice Trust Fund to the Illinois Criminal Justice
20 Information Authority for Violence Against Women awards and
21 grants to state agencies in accordance with applicable laws
22 and regulations for the State portion of federal funds made

1 available by the American Recovery and Reinvestment Act of
2 2009.

3 Section 50. The additional sum of \$23,000,000, or so
4 much thereof as may be necessary, is appropriated from the
5 Criminal Justice Trust Fund to the Illinois Criminal Justice
6 Information Authority for Byrne/JAG awards and grants to
7 state agencies in accordance with applicable laws and
8 regulations for the State portion of federal funds made
9 available by the American Recovery and Reinvestment Act of
10 2009.

11 Section 55. The following named sums, or so much thereof
12 as may be necessary, are appropriated to the Illinois
13 Criminal Justice Information Authority for activities
14 undertaken in support of federal assistance programs
15 administered by units of state and local government and non-
16 profit organizations:

5 Section 60. The following named amounts, or so much
6 thereof as may be necessary, are appropriated to the Illinois
7 Criminal Justice Information Authority for awards and grants
8 and other monies received from federal agencies, from other
9 units of government, and from private/not-for-profit
10 organizations for activities undertaken in support of
11 investigating issues in criminal justice and for undertaking
12 other criminal justice information projects:

18 Section 65. The following named amounts, or so much
19 thereof as may be necessary, respectively, for the objects
20 and purposes hereinafter named, are appropriated to the
21 Illinois Criminal Justice Information Authority for awards,
22 grants and operational support to implement the Motor Vehicle
23 Theft Prevention Act:

15 Section 70. The sum of \$4,500,000, or so much thereof as
16 may be necessary, is appropriated from the Juvenile
17 Accountability Incentive Block Grant Trust Fund to the
18 Illinois Criminal Justice Information Authority for awards
19 and grants to state agencies and units of local government,
20 including operational expenses of the Authority in support of
21 the Juvenile Accountability Incentive Block Grant program.

22 Section 99. Effective date. This Act takes effect July 1,
23 2009.
