1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated to the Board
8 of the Trustees of Northeastern Illinois University to meet
9 ordinary and contingent expenses for the fiscal year ending
10 June 30, 2010:

11 Payable from the General Revenue Fund:

12	For Personal Services, including payment	
13	to the university for personal services	
14	costs incurred during the fiscal year	
15	and salaries accrued but unpaid to academic	
16	personnel for personal services rendered	
17	during the academic year 2009-2010	36,225,600
18	For State Contributions to Social	
19	Security, for Medicare	439,500
20	For Group Insurance	1,077,100
21	For Contractual Services	1,134,700

1	For Equipment	<u>200,800</u>
2	Total	\$39,077,700

3 Section 10. The sum of \$170,000, or so much thereof as
 4 may be necessary, is appropriated from the General Revenue
 5 Fund to the Board of Trustees of Northeastern Illinois
 6 University to conduct a pilot program to improve retention
 7 and graduation rates for minority students.

8 Section 15. In addition to any other amounts
 9 appropriated for such purposes, the following named amounts,
 10 or so much thereof as may be necessary, are appropriated from
 11 the General Revenue Fund to the Board of Trustees of
 12 Northeastern Illinois University for the fiscal year
 13 beginning July 1, 2009, pursuant to Title XIV of the American
 14 Recovery and Reinvestment Act of 2009:

 17 appropriated for such purposes, the following named amounts,

 21 beginning July 1, 2009, pursuant to Title XIV (Other
 22 Government Services) of the American Recovery and
