Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1

5	Section 5. The following named amounts, or so much
6	thereof as may be necessary, respectively, for the objects
7	and purposes hereinafter named, are appropriated to the Board
8	of the Trustees of the University of Illinois to meet
9	ordinary and contingent expenses for the fiscal year ending

16	Section 10. The sum of \$2,445,500, or so much thereof as
17	may be necessary, is appropriated from the Fire Prevention
18	Fund to the Board of Trustees of the University of Illinois
19	for the purpose of maintaining the Illinois Fire Service
20	Institute, paying the Institute's expenses, and providing the
21	facilities and structures incident thereto, including payment
22	to the University for personal services and related costs
23	incurred.

- 1 Section 15. The sum of \$250,000, or so much thereof as
- 2 may be necessary, is appropriated from the State College and
- 3 University Trust Fund to the Board of Trustees of the
- 4 University of Illinois for scholarship grant awards, in
- 5 accordance with Public Act 91-0083.
- 6 Section 20. The sum of \$200,000, or so much thereof as
- 7 may be necessary, is appropriated from the Emergency Public
- 8 Health Fund to the University of Illinois for costs and
- 9 expenses related to or in support of Emergency Mosquito
- 10 Abatement.
- 11 Section 25. The sum of \$200,000, or so much thereof as
- 12 may be necessary, is appropriated from the Used Tire
- 13 Management Fund to the University of Illinois for costs and
- 14 expenses related to or in support of mosquito research and
- 15 abatement.
- Section 30. The sum of \$472,100, or so much thereof as
- 17 may be necessary, is appropriated from the Hazardous Waste
- 18 Research Fund to the University of Illinois for its ordinary
- 19 and contingent expenses.
- Section 35. The sum of \$1,000,000, or so much thereof as
- 21 may be necessary, is appropriated from the General

- 1 Professions Dedicated Fund to the Board of Trustees of the
- 2 University of Illinois for costs associated with the
- 3 development, support or administration of pharmacy practice
- 4 education or training programs for the College of Medicine at
- 5 Rockford.
- 6 Section 40. In addition to any other amounts
- 7 appropriated for such purposes, the following named amounts,
- 8 or so much thereof as may be necessary, are appropriated from
- 9 the General Revenue Fund to the Board of Trustees of the
- 10 University of Illinois for the fiscal year beginning July 1,
- 11 2009, pursuant to Title XIV of the American Recovery and
- 12 Reinvestment Act of 2009:
- 13 For Personal Services\$45,518,600
- 14 Section 45. In addition to any other amounts
- appropriated for such purposes, the following named amounts,
- or so much thereof as may be necessary, are appropriated from
- 17 the General Revenue Fund to the Board of Trustees of the
- 18 University of Illinois for the fiscal year beginning July 1,
- 19 2009, pursuant to Title XIV of the American Recovery and
- 20 Reinvestment Act of 2009:
- 21 For Personal Services\$7,827,500
