A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named sums, or so much thereof  
6 as may be necessary, respectively, for the objects and  
7 purposes hereinafter named, are appropriated to meet the  
8 ordinary and contingent expenses of the Illinois Arts  
9 Council:

10 Payable from the General Revenue Fund:

4 Section 10. The following named sums, or so much thereof  
 5 as may be necessary, respectively, for the objects and  
 6 purposes hereinafter named, are appropriated to the Illinois  
 7 Arts Council to enhance the cultural environment in Illinois:

8 Payable from General Revenue Fund:

9 For Grants and Financial Assistance for  
 10 Arts Organizations .....4,572,300  
 11 For Grants and Financial Assistance for  
 12 Special Constituencies .....1,766,200  
 13 For Grants and Financial Assistance for  
 14 International Grant Awards .....698,900  
 15 For Grants and Financial Assistance for  
 16 Arts Education .....1,085,000  
 17 Total \$8,122,400

18 Payable from Illinois Arts Council

19 Federal Grant Fund:

20 For Grants and Programs to Enhance  
 21 the Cultural Environment .....1,000,000  
 22 For the purposes of Administrative  
 23 Costs and Awarding Grants associated with  
 24 the Education Leadership Institute .....1,000,000

1           Section 15. The sum of \$692,200, or so much thereof as  
2           may be necessary, is appropriated from the General Revenue  
3           Fund to the Illinois Arts Council for the purpose of funding  
4           administrative and grant expenses associated with humanities  
5           programs and related activities.

6           Section 20. The amount of \$314,100 or so much thereof as  
7           may be necessary, is appropriated from the General Revenue  
8           Fund to the Illinois Arts Council for grants to certain  
9           public radio and television stations for operating costs.

10          Section 25. The amount of \$4,052,400 or so much thereof  
11          as may be necessary is appropriated from the General Revenue  
12          Fund to the Illinois Arts Council for grants to certain  
13          public radio and television stations and related  
14          administrative expenses, pursuant to the Public Radio and  
15          Television Grant Act.

16          Section 30. To the extent Federal Funds including  
17          reimbursements are made available for such purposes, the sum  
18          of \$361,600 is appropriated from the Illinois Arts Council  
19          Federal Grant Fund to the Illinois Arts Council for arts  
20          projects and activities pursuant to what is set forth in the  
21          American Recovery and Reinvestment Act of 2009 with regards

1 to the National Endowment for the Arts.

2 Section 99. Effective date. This Act takes effect July 1,  
3 2009.
