AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

5 Section 5. The following named sums, or so much thereof 6 as may be necessary, respectively, for the objects and 7 purposes hereinafter named, are appropriated to meet the 8 ordinary and contingent expenses of the Department of 9 Military Affairs:

The sum of \$11,500,000, or so much thereof 1 Section 10. as may be necessary, is appropriated from the Federal Support 2 Agreement Revolving Fund to the Department of Military 3 Affairs Facilities Division for expenses related to Army 4 5 National Guard Facilities operations and maintenance as provided for in the Cooperative Funding Agreements, including 6 costs in prior years. 7

8 Section 15. The sum of \$528,800, or so much thereof as 9 may be necessary, is appropriated from the Federal Support Agreement Revolving Fund to the Department of Military 10 Affairs Facilities Division for expenses related to 11 the Bartonville and Kankakee armories for 12 operations and maintenance according to the Joint-Use Agreement, including 13 14 costs in prior years.

15 Section 20. The sum of \$7,400, or so much thereof as may 16 be necessary, is appropriated from the General Revenue Fund 17 to the Department of Military Affairs Office of the Adjutant 18 General Division for expenses related to the care and 19 preservation of historic artifacts.

20 Section 25. The sum of \$1,432,000, or so much thereof as 21 may be necessary, is appropriated from the Military Affairs SB2433 -4- OMB096 00035 KML 10035 b Trust Fund to the Department of Military Affairs Office of the Adjutant General Division to support youth and other programs, provided such amounts shall not exceed funds to be made available from public or private sources.

Section 30. The sum of \$5,000,000, or so much thereof as 5 may be necessary, is appropriated from the Illinois Military 6 Family Relief Fund to the Department of Military Affairs 7 Office of the Adjutant General Division for the issuance of 8 9 grants to persons or families of persons who are members of 10 the Illinois National Guard or Illinois residents who are members of the armed forces of the United States and who have 11 12 been called to active duty as a result of the September 11, 2001 terrorist attacks, including costs in prior years. 13

14 Section 35. The sum of \$2,250,000, or so much thereof as 15 may be necessary, is appropriated from the General Revenue 16 Fund to the Department of Military Affairs for transfer into 17 the Illinois Military Family Relief Fund.

Section 99. Effective date. This Act takes effect July 1,2009.
