2 WHEREAS, The members of the Illinois Senate are saddened to 3 learn of the death of Stephen J. Laing of Woodstock, who passed 4 away on February 1, 2009; and

5 WHEREAS, He was born June 3, 1939, in Chicago, to James E. 6 and Lorraine E. nee McCabe Laing; he married Sharon "Shari" 7 Gould on May 5, 1962, in Woodstock; and

WHEREAS, After his education, he joined the United States Marine Corps and served from 1957 to 1960; after his tour of duty, he started a lifelong journey as a firefighter; he got his start in fire service in Wonder Lake on the Highland Shores Rescue Squad in 1960 and continued with that department until 1980, retiring as assistant chief; in 1972, he began his full-time career on the Skokie Fire Department and retired from there in 1996 as a lieutenant; in 1980, after moving to Woodstock, he joined the Woodstock Fire & Rescue Department and retired as captain in 1991; he began his career with the McHenry Township Fire Protection District in 1987, leading the fire prevention bureau and moving up to the rank of assistant chief when he retired in 2006; the past few years he had been working as a consultant in the fire prevention bureau for Woodstock; and
