SENATE RESOLUTION

2 WHEREAS, The members of the Illinois Senate are saddened to 3 learn of the death of State Representative Richard P. Myers of 4 Colchester, who passed away on December 1, 2010; and

5 WHEREAS, He was born to John and Martha Myers on December 6 27, 1947 in Macomb; he married Christine Sims on August 9, 1975 7 in North Henderson; he graduated from Colchester High School in 8 1966 and earned a Bachelor of Science in Agronomy from Western 9 Illinois University in 1973; and

10 WHEREAS, Representative Myers farmed his family farm for 29 11 years and served 6 years in the United States Army Reserves; he 12 was an active member and elder of the Scotland Trinity 13 Presbyterian Church; and

14 WHEREAS, During his farming career, Representative Myers 15 was active in the Farm Bureau organization, serving in various capacities at the local, State, and national levels; he served 16 12 years as a member of the board of directors of the Illinois 17 18 Farm Bureau; during that time he represented the Illinois Farm 19 Bureau on the board of directors of the Interstate Producers Livestock Association, the U.S. Meat Export Federation, and 20 21 numerous other agricultural organizations; and

SR1116 -2- LRB096 24686 KXB 44644 r WHEREAS, Representative Myers served several years as minority spokesperson of the Appropriations-Higher Education Committee and was a strong advocate for increased funding for the State's public colleges and universities, as well as for the State's community college system; and

6 WHEREAS, Representative Myers served on the Agriculture 7 Conservation, Higher Education, State and Government 8 Administration, Elections and Campaign Reform, and Renewable 9 Energy Committees; he served as a member of the Passenger Rail 10 Caucus, a group of legislators advocating for continued and 11 expanded Amtrak service throughout the State; and

12 WHEREAS, Representative Myers was co-chair of the 13 Commission on Government Forecasting and Accountability, a 14 bi-partisan legislative commission of members from both 15 chambers; their responsibilities include forecasting State revenue projections, oversight of employee insurance programs, 16 17 and conducting hearings on the proposed closure of State facilities; and 18
