10	Sec. 2605-90. Training; death and homicide investigations.
11	The Department shall provide training in death and homicide
12	investigation for State police officers. Only State police
13	officers who successfully complete the training may be assigned
14	as lead investigators in death and homicide investigations.
15	Satisfactory completion of the training shall be evidenced by a
16	certificate issued to the officer by the Department.

15	The Illinois Law Enforcement Training and Standards Board shall
16	conduct or approve a training program in death and homicide
17	investigation for the training of law enforcement officers of
18	local government agencies. Only law enforcement officers who
19	successfully complete the training program may be assigned as
20	lead investigators in death and homicide investigations.
21	Satisfactory completion of the training program shall be
22	evidenced by a certificate issued to the law enforcement
23	officer by the Illinois Law Enforcement Training and Standards
24	Board.
