SYNOPSIS AS INTRODUCED:

20 ILCS 2605/2605-407 new 20 ILCS 4005/8.5 new

Amends the Department of State Police Law of the Civil Administrative Code of Illinois. Creates the Illinois State Police Federal Projects Trust Fund as a federal trust fund in the State treasury. Provides that the State Police Federal Projects Trust Fund is established to receive funds awarded to the Department of State Police from all federal departments and agencies for the specific purposes established by the terms and conditions of the federal awards. Requires that all interest earned by the investment or deposit of monies accumulated in the Trust Fund shall be deposited into the Trust Fund, except if the terms and conditions of the federal award otherwise provides. Amends the Illinois Motor Vehicle Theft Prevention Act. Creates the State Police Motor Vehicle Theft Prevention Trust Fund. Provides that moneys in the Trust Fund shall be used by the Department of State Police to make grants for motor vehicle theft prevention purposes.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The Department of State Police Law of the Civil 5 Administrative Code of Illinois is amended by adding Section 2605-407 as follows: 6

- Sec. 2605-407. Illinois State Police Federal Projects 8 9 Trust Fund. The Illinois State Police Federal Projects Trust Fund is created as a federal trust fund in the State treasury. 10 This Trust Fund is established to receive funds awarded to the 11 Department of State Police from all federal departments and 12 agencies, including without limitation the Department of 13 14 Homeland Security, for the specific purposes established by the terms and conditions of the federal awards. All interest earned 15 16 by the investment or deposit of monies accumulated in the Trust Fund shall be deposited into the Trust Fund, except if the 17 terms and conditions of the federal award otherwise provides. 18
