A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated to meet the
8 ordinary and contingent expenses of the Illinois Criminal
9 Justice Information Authority:

3 Section 15. The sum of \$40,000,000, or so much thereof
4 as may be necessary, is appropriated from the Criminal
5 Justice Trust Fund to the Illinois Criminal Justice
6 Information Authority for awards and grants to local units of
7 government and non-profit organizations.

8 Section 20. The additional sum of \$500,000, or so much
9 thereof as may be necessary, is appropriated from the
10 Criminal Justice Trust Fund to the Illinois Criminal Justice
11 Information Authority for Crime Victims Assistance awards and
12 grants to local units of government and non-profit
13 organizations in accordance with applicable laws and
14 regulations for the State portion of federal funds made
15 available by the American Recovery and Reinvestment Act of
16 2009.

17 Section 25. The additional sum of \$4,600,000, or so much
18 thereof as may be necessary, is appropriated from the
19 Criminal Justice Trust Fund to the Illinois Criminal Justice
20 Information Authority for Violence Against Women awards and
21 grants to local units of government and non-profit
22 organizations in accordance with applicable laws and

1 regulations for the State portion of federal funds made
2 available by the American Recovery and Reinvestment Act of
3 2009.

4 Section 30. The additional sum of \$23,000,000, or so
5 much thereof as may be necessary, is appropriated from the
6 Criminal Justice Trust Fund to the Illinois Criminal Justice
7 Information Authority for Byrne/JAG awards and grants to
8 local units of government and non-profit organizations in
9 accordance with applicable laws and regulations for the State
10 portion of federal funds made available by the American
11 Recovery and Reinvestment Act of 2009.

12 Section 35. The sum of \$12,000,000, or so much thereof
13 as may be necessary, is appropriated from the Criminal
14 Justice Trust Fund to the Illinois Criminal Justice
15 Information Authority for awards and grants to state
16 agencies.

17 Section 40. The additional sum of \$500,000, or so much
18 thereof as may be necessary, is appropriated from the
19 Criminal Justice Trust Fund to the Illinois Criminal Justice
20 Information Authority for Violence Against Women awards and
21 grants to state agencies in accordance with applicable laws
22 and regulations for the State portion of federal funds made

1 available by the American Recovery and Reinvestment Act of
2 2009.

3 Section 45. The additional sum of \$15,000,000, or so
4 much thereof as may be necessary, is appropriated from the
5 Criminal Justice Trust Fund to the Illinois Criminal Justice
6 Information Authority for Byrne/JAG awards and grants to
7 state agencies in accordance with applicable laws and
8 regulations for the State portion of federal funds made
9 available by the American Recovery and Reinvestment Act of
10 2009.

11 Section 50. The following named sums, or so much thereof
12 as may be necessary, are appropriated to the Illinois
13 Criminal Justice Information Authority for activities
14 undertaken in support of federal assistance programs
15 administered by units of state and local government and non-
16 profit organizations:

1 Section 55. The following named amounts, or so much
 2 thereof as may be necessary, are appropriated to the Illinois
 3 Criminal Justice Information Authority for awards and grants
 4 and other monies received from federal agencies, from other
 5 units of government, and from private/not-for-profit
 6 organizations for activities undertaken in support of
 7 investigating issues in criminal justice and for undertaking
 8 other criminal justice information projects:

9	Payable from the Criminal Justice

11	Payable from the Criminal Justice	
12	Information Projects Fund.....	<u>400,000</u>
13	Total	\$2,100,000

14 Section 60. The following named amounts, or so much
 15 thereof as may be necessary, respectively, for the objects
 16 and purposes hereinafter named, are appropriated to the
 17 Illinois Criminal Justice Information Authority for awards,
 18 grants and operational support to implement the Motor Vehicle
 19 Theft Prevention Act:

20	Payable from the Motor Vehicle	
21	Theft Prevention Trust Fund:	
22	For Personal Services	191,100
23	For other Ordinary and Contingent Expenses	187,100

1	For Awards and Grants to federal	
2	and state agencies, units of local	
3	government, corporations, and

6	activities and programs undertaken	
7	by the Authority in support of the	
8	Motor Vehicle Theft Prevention Act	6,500,000
9	For Refunds	<u>75,000</u>
10	Total	\$6,953,200

11 Section 65. The sum of \$4,500,000, or so much thereof as
 12 may be necessary, is appropriated from the Juvenile
 13 Accountability Incentive Block Grant Trust Fund to the
 14 Illinois Criminal Justice Information Authority for awards
 15 and grants to state agencies and units of local government,
 16 including operational expenses of the Authority in support of
 17 the Juvenile Accountability Incentive Block Grant program.

18 Section 99. Effective date. This Act takes effect July 1,
 19 2011.
