3 line 11, after "Health", by inserting "and the Department of
4 Children and Family Services"; and

8 serve as the co-chairperson of the Council"; and

17 recommendations to the pertinent Department regarding the
18 development of rules, procedures, and forms that will promote
19 the efficient and effective operation of (i) the Illinois
20 Adoption Registry, (ii) the Office of Vital Records as it
21 pertains to the Registry and to access to the non-certified
22 copy of the original birth certificate, and (iii) the

1 Confidential Intermediary Program in Illinois. The Council
2 will also serve in an advisory capacity regarding the"; and
